I am directed to convey that the University has accorded permission to run the P.G. Diploma Course in -

on self sufficiency basis in your Department from the session 1999-2000 with the understanding that no financial assistance/help will be granted by the University for the purpose. The Diploma run by your department is granted permission on the following conditions:-

- A. THE P.G. DIPLOMA COURSES SHALL BE STARTED EXCLUSIVELY ON SELF SUFFICIENCY BASIS *i.e.* THE SOURCES GENERATED BY THE DEPARTMENT CONCERNED.
- B. THE DIPLOMA COURSES WILL BE STARTED ONLY WHEN THE MINIMUM STUDENTS AS PRESCRIBED BY THE UNIVERSITY HAVE BEEN ADMITTED TO THE COURSE AND DEPOSITED FEE AFTER THEIR ADMISSIONS.
- C. THE DEPARTMENT SHOULD MAINTAIN THE CONCERNED ACCOUNT FOR COURSE RUN ON SELF SUFFICIENCY BASIS. ALL PAYMENTS/EXPENSES FOR PAYMENTS TO TEACHING/NON-TEACHING STAFF WILL BE MADE BY THE DEPARTMENT CONCERNED.
- D. THE FEE COLLECTED FOR LIBRARY AND AMENITIES ETC. WILL BE TRANSFERRED TO THE UNIVERSITY ACCOUNTS AFTER ADMISSIONS ARE COMPLETED.
- E. 15% OF THE REVENUE WILL BE TRANSFERRED TO THE UNIVERSITY ACCOUNTS AFTER REALISATION OF THE FEES FROM THE STUDENTS.
- F. AT THE END OF THE YEAR IN CASE OF SURPLUS FUNDS LEFT AFTER MEETING THE EXPENDITURE FOR THE SESSION 20% OF THE SAME WILL BE DEPOSITED IN THE UNIVERSITY ACCOUNTS.

You are, therefore, requested to kindly ascertain as to compliance of the above conditions before the admissions are made in the diploma run by your department. I may also add for your information that the University has also vide office letter No. JNVU/Aca/A/9014-18 dated 30.3.98 has sent you guidelines regarding fee structure and other modus operandi of the diploma courses to be run by the department on self sufficiency basis.


