In view of the direction of the State Government as well as decision of the Syndicate Meeting held on 14th December, 2021, the benefit of promotion in lieu of fixation with effect from the date eligibility to the recommendation of the committee as approved by the Syndicate, shall be treated as Notional and the actual payment/ arrears shall be paid from the date of Syndicate meeting held on 14.12.2021 in which the recommendation of the selection committee was approved.
