आरक्षण नीति, नियमों एवं निर्देशों की पालना करते हुए विश्वविद्यालय को एक इकाई मानते हुए रोस्टर पंजिका के संधारण हेतु निम्न प्रकार निर्देश जारी किये जाते हैं:-

These instructions shall be called as the detailed instructions for the implementation of reservation and maintenance of the roster considering University as one unit for the direct recruitment on the post of teaching / equivalent cadres.

(i) Reservation rules will be implemented, considering the University as one unit. It is clarified that for the purpose of reservation of the post in direct recruitment in teachers/ equivalent cadres, the University shall be regarded as one unit.


1. For the purpose of reservation of the posts to be filled through direct recruitment in teachers' cadre, the University shall be considered as one Unit. Provisions of considering University as one unit in teachers' cadre shall be deemed to have come into force with effect from 07-03-2019 i.e. from date of its gazette notification by MHRD.

2. All the advertisement for direct recruitment issued on 07.03.2019 or thereafter, shall be regulated by the reservation policy, considering University as one Unit. All the advertisement which were issued before 07.03.2019 and in which examinations have been conducted successfully or results have been declared or even a single appointment has been made, then the recruitment under such advertisement will be governed by the then reservation rules, which existed at the time of advertisement prior to 07.03.2019. Those advertisements in which no activity related to final selection i.e. examination or interview etc. has been completed and the recruitment process is still pending at the level of advertisement and inviting of application, in such cases the new rule notified on 07.03.2019 will apply and the vacancies have to be plotted in the new roster accordingly.

The Roster Register have to be maintained for all teachers cadres. Here **teachers' cadre** means "a class of teachers regardless of the branch of study or faculty, who once remunerated at the same grade of pay, including allowance or bonus" and **equivalent cadre** means "the service cadres have equivalent pay scale & grade pay", for example Director Physical Education, Librarian are equivalent for the purpose of operation of reservation through roster.

3. (a). A separate roster register will be maintained for the direct recruitment on the post of Professor or its equivalent cadres. All service cadres of Professor are equivalent to Professor Cadre:

For example, the post of Director in Physical Education, Librarian, and any other posts having same salary scale, same grade pay, and requiring equivalent qualifications for eligibility as that for Professor are equivalent cadres to Professor. All such service cadres shall be grouped together with the Professor cadre for operation of reservation through a roster.

- (b). First of all, all Professors working as on 07.03.2019 in various departments and other equivalent posts are to be plotted in the roster strictly as per the chronological order of their appointments made on that post.
- (c). For the purpose of determining reservation, the vacancies occurring in various constituent of the groups shall be plotted on the roster strictly in chronological order, i.e. sequence of date of occurrence of vacancies (Grouping of posts rules, DOPT, Govt. of India). All vacant posts of Professor/ equivalent cadre (in whole university) existing on date immediately preceding to the date of advertisement must be plotted on roster to earmark posts for various categories for the purpose of recruitment through advertisement.

Ex.1: In some cases, the teacher working on the post of Professor is retired on last day of a month. In such cases, two or more teachers working on the post of Professor may be retiring on the same day i.e. last day of a month. In such cases, the actual date of retirement of the teacher (say 60 years) shall be considered. For example, 'A' attains age 60 on 12-01-2020, and 'B' attains on 23-01-2020, then both 'A' & 'B' shall superannuate on 31-01-2020. Therefore, in such a case, the posts vacated by 'A' & 'B' shall be considered to have fallen vacant on 12-01-2020 and 23-01-2020, respectively, and the post vacated by "A" will be plotted first in the roster. If even after this actual date of attaining retirement (as per the birth day as explained as 12-01-2020, 23-01-2020), two or more posts become vacant on same date, then vacant posts belonging to different subjects shall be entered on roster alphabetically. For example, a post of Prof. (Geography) becomes vacant on 12-01-2020, and also a post of Prof. (Botany) becomes vacant on 12-01-2020. In this case, the vacancy of Prof. (Botany) w.e.f. 12-01-2020) will be plotted first and thereafter, the vacancy of Prof. (Geography) will be plotted in the roster.

4. Like wise separate roster registers shall be maintained for the direct recruitment on the post of Associate Professor and Assistant Professor or their equivalent cadres by adopting the same methodology as mentioned above in point no. 3.
5. Roster Registers in all cadres or its equivalents shall be maintained separately as per the circular issued by State Government of Rajasthan vide no.7 (2) Karmik/Ka-2/19 dated 24.02.2020 and the vacancies available are to be shown and earmarked as above (c).

Ex.4: Say, as on 7-3-2019, the total cadre of Professor & equivalent post (Director-Phy. Educ., Librarian, Director, etc.,) is 48. Out of 48 posts, three posts are lying vacant, i.e., Botany professor one post since 11-10-2017, Chemistry Professor one post since 11-10-2018 and one Zoology professor post since 11-10-2018. As 45 professors and their equivalent are already present in the roster, therefore roster will start further from roster point No.46. The vacant posts with subject shall be plotted in roster starting from roster point number 46 & in sequence of the posts in which they became vacant. If two subjects or more subjects have posts vacant on the same date then these posts shall be entered in roster alphabetically. It means the Botany Professor Vacancy, Chemistry Professor Vacancy, and Zoology Professor Vacancy will be plotted against roster point's 46-UR, 47-UR, and 48BC, respectively" and all three posts shall be earmarked and advertised as 2UR and 1BC, say in recruitment year 2020, provided there is no previous backlog of SC/ST on professor posts in these subjects. Suppose, Mr. X, Y & Zs are appointed professors in Botany, Chemistry, and

Zoology, respectively. Two of them belong to UR and one from OBC category, and are appointed, say on 23-06-2020 all this information will be entered in the roster. Similar process and methodology shall be applicable for maintaining the separate roster for the posts of Associate Professor, Assistant Professor and or its equivalent cadres.

6. The backlog/ carried forward reservation of SC/ST/PWD existing on previous roster (roster which existed prior to 7.3.2019) will be carried forward to this new roster. Treatment of previous Backlog/Carry forward reservation of SC/ST/PWD if exist as per the then prevailing rules enforced at that time, shall be governed by the Section 13,14 and 15 of the Circular issued by the State Government vide no.F.15(24)DOP /AII/75 dated 24.06.2008 and any other order issued thereafter by the State Government.

I Horizontal Reservation for Women

Horizontal reservation for Women will be applicable for Women for the posts of Professor, Associate Professor and Assistant Professor and their equivalent cadre. Separate rosters for women in each cadre shall be maintained as per the Appendix - 2 attached with State Government Circular Pa 7(2) Karmik / Ka-2 /19 date 24-02-2020.

Note: Six rosters, one each for UR/SC/ST/OBC/MBC/EWS categories for providing reservations to women shall be maintained for horizontal reservation.

- A. Implementation of Horizontal reservation for women in various cadres has always been a difficult issue due to lack of understanding about implementation of horizontal reservation or other reasons. Therefore, operation of Horizontal reservation for women is being explained in detail with examples.


Operation of horizontal Reservation for SC Women for the recruitment on the post of Professor, Associate Professor and Assistant Professor or their equivalent cadre considering University as one unit will be as:

Consider the case of Professors and their equivalents. Here for deciding reservation for women of SC category, we have to take in to account the Professor/equivalent posts with subjects reserved for SC category chronologically starting from 7.3.2019, and all these posts reserved for SC have to be plotted in table-3 chronologically (if the date is same, then follow alphabetically).

For example, say.

Librarian (10.10.19) is to be reserved for SC in recruitment year 2021.

Law professor (1.5.2020) is to be reserved for SC in recruitment year 2022.

These posts (with subjects) shall be plotted in table-3 starting from point no.1. Thus, in the year 2023, the post of professor of Psychology is to be earmarked for SC Women. and is to be filled by SC women, failing which this post may be interchanged by SC widow/divorcee of Psychology, and failing which by the SC male of Psychology in recruitment year 2023 itself. Thereafter, the SC Women roster will run from point 5 onwards till point 100 to earmark posts reserved for SC women/widow/divorcee, as the case may be. Thereafter, the new similar 100 point cycle will be repeated.

Similarly, the rosters for UR women (by plotting earmarked professor posts for UR only), ST women (by plotting reserved professor posts for ST only), OBC women (by plotting reserved professor posts for OBC only), MBC women (by plotting reserved professor posts for MBC only), and EWS women (by plotting reserved professor posts for EWS only) shall be operated.

For filling SC women posts of professor Psychology, a separate merit list having only name of SC women/widow/divorcee of computer in recruitment 2023 year will be prepared. The women on the highest merit list of SC /widow/divorcee of computer will be appointed to fill posts reserved for SC women/widow/divorcee, as the case may be, in recruitment year 2023,


Similar pattern will be followed for women of ST, OBC, MBC, and EWS. However, the case of reservation for UR women is bit different. Whenever, there is a vacancy reserved for UR women (say in Hindi in a recruitment year 2024), then the merit list of Hindi having all women candidates of all categories (including EWS, OBC, SC, ST, MBC) of Hindi subject of recruitment year 2024 will be prepared. The women on the highest merit in this list will be appointed against the reserved post for the women/widow/divorcee, as the case may be.

Reservation for women will be applicable only when numbers of women required in each Category as per quota are not selected on their own merit. For example, if there are two vacancy of professor in chemistry in recruitment year 2025, and both happens to be earmarked for UR as per roster in Table-1, and also one of these posts happen to be reserved for UR women as per the operation of the rosters for horizontal reservation for UR women (by plotting earmarked professor posts for UR only). Suppose, in the merit list for UR category for filling two vacancy of professor in chemistry in recruitment year 2025, at first rank women of UR and at second rank there is a male of UR, then in such a case, a woman has already got selected on chemistry professor post in 2025, therefore, there is no need of taking one more women on the basis of horizontal reservation.

In the above example implementation of women reservation has been explained from starting roster point for better understanding of the matter. In women's case also the person working already has to be plotted in the register first of all.

Implementation of Horizontal reservation for Persons with disabilities (PWD) in various cadres has always been a challenge. Therefore, operation of Horizontal reservation for Persons with disabilities (PWD) is being explained in detail with examples.

Consider the case of Professor and its equivalent cadre.


(a). Horizontal Reservation for Persons with disabilities (PWD) on the post of Professor or its equivalent cadre:

There will be only one roster for operation of horizontal reservation for persons with disabilities (PWD) on the post of Professor/equivalent cadre. For providing reservation to PWD, we have to take into account, the Professor equivalent posts with subjects to be filled including all categories (UR/SC/ST/OBC/MBC/EWS) chronologically starting from 7.3.2019, and all these posts have to be plotted in **Table-3** chronological order (if date is same, then alphabetically) similar to as in Table-1. It is clear from the Table-3 that the Botany professor (UR) is horizontally reserved for the PWD of LV benchmark disabilities. That means for filling this post, a separate merit list of all PWD applicants of BVLV category of all categories UR/OBC/EWS/MBC/SC/ST belonging to Botany professor vacancy will be prepared. The highest in this merit of B/LV will be offered appointment on the post of Botany professor B/LV. If the person of UR is on highest rank then it is normal. But, if the highest rank holder is of say from OBC, and then this OBC B/LV will be appointed on this post by mentioning that this Botany professor OBC reservation will be adjusted in future. If this PWD horizontal reservation belongs to vertical SC reservation, in that case, the PWD of only SC category will be offered appointment. No PWD of other category (UR/ST/OBC/MBC/EWS) can be given appointment on this SC-PWD post since it is vertically reserved for the SC, whereas in case of UR-PWD, it belongs to vertically earmarked open competition category.

(b). Carry forward of Horizontal Reservation for Persons with disabilities (PWD) on the post of Professor or its equivalent cadre:

The basic rule for filling reservation to PWD candidates is that, they will be provided two attempts in all to fill PWD post. In original recruitment year, it will be filled by the benchmark disabilities for which it is reserved. If it is not filled in original recruitment year, then it will be filled in next recruitment year by the original benchmark disabilities first, failing which by the interchange to other disabilities in sequence (b), (c), (d & e). If even after this exchange, it remains vacant then it may be filled by normal candidate of same vertical reservation.

Example: Consider the case in which botany professor (UR) is reserved for B/LV PWD in recruitment year 2020. It will be filled by the B/LV in 2020 itself, failing which it will be carried forward to next recruitment year say 2021. In year 2021, first it will be tried to be filled by B/LV, if B/LV of botany is not available, then it will be filled by other disabilities in sequence (b), (c), (d & e), of the same subject i.e. botany. If other disabilities (b), (c), (d & e) are also not available, then this Botany professor

(URVB/LV will be filled by normal (non-PWD) UR candidate Wherever in any recruitment year any vacancy cannot be filled up due to non-availability of a suitable person with benchmark disability or for any other sufficient reasons, such vacancy shall be carried forward in the succeeding recruitment year and if in the succeeding recruitment year also suitable person with benchmark disability is not available, it may first be filled by interchange among the five categories and only when there is no person with disability available for the post in that year the employer shall fill up the vacancy by appointment of a person other than a person with disability (THE RIGHTS OF PERSONS WITH DISABILITIES ACT, 2016 (NO 49 OF 2016) (27th December, 2016).

The PWD, roster will operate without any gap. If in a recruitment year its last point of consuming is 46, then in next recruitment year, the points 47 onwards shall be consumed till the 100th point. After that, a new cycle of similar roster points for PWD will be used. The roster of PWD is divided in four blocks; 1st block from 1-25 with 1st point reserved for PWD (a) disabilities, 2nd block from 26-50 with 26 point reserved for PWD (b) disabilities, 3rd block from 51-75 with 51st point reserved for PWD (c) disabilities and 4th block from 76-100 with 76th point reserved for PWD (d) and (e) disabilities.

It is to be made clear that if a backlog of PWD B/LV of Professor post of Zoology (of recruitment year say 2015) existed on 7.3.2019, then the Zoology professor (11.10.2018); earmarked for UR will also be advertised as reserved for the B/LV along with the botany for PWDB/LV This will be treated as second attempt to fill zoology professor PWD B/LV backlog, and will be dealt with as explained for botany professor PWDB/LV.

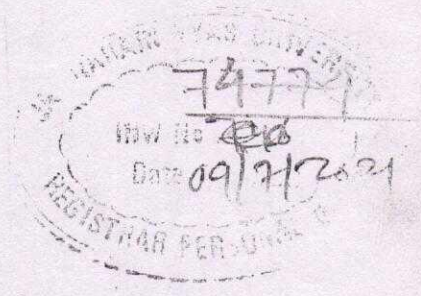
