





6. The institute/College shall not charge any overheads/plans on this project and will provide all the administrative support for completion of the project.
 7. The grantee shall utilize grants on only approved items of expenditure as mentioned in the abstract of cost certified by the PWD of the State. However in case the grantee wishes to recast the project, approval of the Council must be obtained for the revised item of expenditure and they will maintain proper accounts of the expenditure as per the norms/procedures of AICTE/Government of India.
 8. The Hostel building so constructed wholly or substantially out of All India Council for Technical Education's grant shall not be disposed or encumbered or utilize for the purpose other than those for which the Grant was given without proper sanction of the All India Council for Technical Education.
 9. The grantee shall maintain a Management Book and Site Order Book in the prescribed format of PWD and the same shall be open to AICTE or any Officer(s) authorized by the Council for inspection.
 10. The minimum carpet area of the entire Hostel should not be less than 1040 sqm.

 12. The Institute shall maintain proper accounts of the expenditure out of the Grants which shall be utilized only on approved items of expenditure. The Institute is required opening a separate Bank Account to get the interest on accumulation of this grant/fund received from AICTE.
 13. Interest on the sanctioned grant-in-aid will be reported back to AICTE and may be adjusted against the subsequent installment.
 14. The Annual Progress Report in the prescribed format along with Statement of Expenditure and Audited Utilization Certificate shall be submitted to AICTE not later than one month after completion of initial construction against the sanctioned amount of 1st installment followed by actual expenditure statement, in brief, from the Constructing Agency duly verified by the Head of Institute.




