The Hon'ble Vice-Chancellor, Jai Narain Vyas University, Jodhpur has constituted a three members committee (Dr.Vijay Singh, Member Syndicate, Dr. Vinod Sharma, Member Syndicate and Prof. R.C.Meena, Department of Chemistry, JNVU, Jodhpur) vide order No.JNVU/Estt/T/962 dated 6<sup>th</sup> February, 2019 with corrigendum No.JNVU/Estt/T/1076 dated 5<sup>th</sup> March, 2020 and in continuation to order No.JNVU/Estt/T/1084 dated 7<sup>th</sup> March, 2020 to review the representations submitted by the teachers "जय नारायण व्यास विश्वविद्यालय, जोधपुर में वर्ष 2013 में चयनित आचार्यों के सेवा समाप्ति आदेशों की पुनः निष्पक्ष जाँच करवाने बाबत्।"

On the basis of observations, committee recommended that 'the appointment of Assistant Professor against advertisement No.74/2011-12 issued by the Jai Narain Vyas University, Jodhpur candidates of case-I does not suffer from any illegality, therefore, the administrative authorities can review/revised the termination order dated 14.05.2017 and also recommended to seek legal advice. Similarly, ACB has dismissed the challan as per order issued by the office of the Director General of Anti Bureau (ACB), Jaipur vide letter ब्यूरो/अशा/3/20/4443-44 दिनांक 7.7.2020 states "इस कार्यालय के पूर्व पत्रांक 11078-81 दिनांक 04.12.2018 द्वारा लिए गये चालान निर्णय को संशोधित किया जाकर, आदेश में वर्णित 26 आरोपियों के विरुद्ध चालान निरस्त किया।"The University also sought current status report of this matter from ACB.

The Jai Narain Vyas University, Jodhpur has asked for the legal opinion from AAG, Rajasthan High Court, Jodhpur on the recommendations submitted by the Committee and ACB Report vide letter No.JNVU/Estt/T/2020/1590 dated 27.7.2020. Shri Farzand Ali, AAG, Rajasthan High Court has given the legal opinion as:

'The order dated 14.05.2017, whereby services of above said persons were terminated can be reviewed or revised on the basis of subsequent development, change of circumstances and fresh material.
