A written complaint from Shri Surendra Yadav III BE EEE dated 03.06.2018 along with the FIR No. 0199 dated 03.06.2018 was referred to the Dean, Faculty of Engineering Jodhpur which was forwarded to the Chief Warden, Engineering College Hostels, Jodhpur for taking disciplinary action at his end. The Chief Warden called an emergent meeting of the wardens on 05.06.2018 to resolve the matter. Injured students also appeared in the wardens meeting to substantiate their complaint. A group of wardens inspected the hostel no 3 and inquired about the incidence. Based on the facts found at hostel and considering past history of the students, the committee of wardens resolved to expel the following students from the hostels and debar from entering in the hostel.

- 1. From hostel No. 3;-Shri Saurabh Jagarwal, Rajkumar, Shree Kant Meena, Khemraj Meena
- 2. From hostel No. 2:- Dinesh Meena and Krishna Kant Meena.

The committee further resolved unanimously to recommend therustication from the University of these Students along with Alok Meena and Narendra Meena (both non hostellers) with immediate effect and it was also resolved to recommend to debar from all examination henceforth. The minutes of the meeting was sent to higher authorities including the Dean, Faculty of Engineering Jodhpur for further necessary action.

Based on the recommendations of wardens, the Dean, faculty of Engineering Jodhpur called a meeting of Anti-ragging & Disciplinary committee, held on 09.06.2018 vide notification No JNVU/DFE/18/421 dated-07.06.2018 for recording the statements and information from the all allegedly involved students in the quarrel. Out of eight students only three students (Saurabh Jagarwal, Dinesh Chand Meena, Krishan Kant Meena) reported to the committee. Some of these



Statements of these three students were recorded on the paper separately in the presence of the committee members. Based on these statements and FIR no. 0199 dated 03.06.2018 against them following decision were taken in the meeting on 09.06.2018

- 1. It was resolved to suspend the all these eight students with immediate effect till further order.
- 2. Remaining five students will be called to present themselves before the committee.
- 3. Their examination results will be withheld till the enquiry of this case is not be completed.
- 4. It was further resolved that students will be rusticated from the university if found guilty in this case.

In compliance of these recommendations other students were given a chancethrough notice no. JNVU/DFE/18/425 dated- 25.06.2018 to present themselves before the committee on 02.07.2018 at the Dean's Office and the students appeared in the previously scheduled examinations by producing an undertaking on Nonjudicial Stamp papers to the examination superintendent, MBM Engineering College, Jodhpur that if the students are found guilty in this case, his examination may be considered as cancelled.

Four students (Raj Kumar Meena, Shrikant Meena, Alok Meena and Narendra Meena) reported to the committee and told some facts of the incident. The committee members also interrogated three students individually to know the actual reason of this quarrel and their statements were recorded. In the meeting, committee members were of the opinion, that (Khem Raj Meena) should be given special chance to present himself before committee and his father, Shri Ramkesh Meenashould be requested to ensure the presence of Khemraj Meena in the meeting on 16.07.2018. The meeting was rescheduled, to be held on 20.07.2018 and accordingly information was sent through letter vide no. –JNVU/DFE/18/545, dated 14.07.2018 But Khemraj Meena did not turn up to the meeting on 20.07.2018 due his illness at Delhi. On special request of his father, another date of hearing was set as 25.10.2018, he was interrogated in the meeting and his statements were also recorded on the same day.

In the beginning, students were taken by local police in their custody for some time, warned and instructed them, not to go back to the hostel. Despite the warning passed by the police, students went to the hostel and again started creating nuisance in hostel. This time students were arrested by the police, presented them before magistrate and sent directly to the Central Jail, Jodhpur. These students were later released from the Jail on bail. Still the inquiry is continuing by the police.

Since complainants and respondents are students of B.E. final year and third year of session 2017-18. Committee members were of opinion that it is not a case of ragging and quarrel had taken place among the students. After going through all the points raised by the complainant and critical examination of the statements of the respondents, committee members concluded that all these eight students (respondents) were involved in the quarrel but could not identify the students who attempted murder of the students. Local police is also inquiring about this case to reach a final decision.

- (व) अनुशासनहीनता: छात्रों के लिए दण्ड प्रावद्यान:
- अनुशासनहीनता की घटना की सूचना तुरन्त परिसर के सम्बन्धित अधिकारी को देनी चाहिए। सम्बन्धित अधिकारी (अधिष्ठाता / निदेशक / विभागाध्यक्ष / चीफ वार्डन / वार्डन / प्रोक्टर/कुल सचिव/उप कुल सचिव/पुस्तकालयाच्यक्ष/ अभियन्ता / सचिव, छात्र एवं क्रीड़ा मण्डल / स्वास्थ्य अधिकारी आदि) प्रारम्भिक जांच कर घटना की सूचना मय टिप्पणी के तुरन्त मुख्य कुलानुशासक को मेजेंगे। इसके आघार पर मुख्य कुलानुशासक अनुशासनहीनता से निपटने के लिए आगे कार्यवाही करेंगे।
- जब कोई छात्र गम्भीर अपराध, गम्भीर दुराचरण, दायित्त्वों के प्रति सतत् उपेक्षा अथवा दुर्व्यवहार के कारण दोषी पाया जायेगा, तो मुख्य कुलानुशासक उसे कक्षा में जाने से निलम्बित कर देंगे। उस निलम्बन की अवधि में, जो पहली बार में छः मास से अधिक नहीं होगी, वह छात्र विश्वविद्यालय, संघटक/सन्बद्ध महाविद्यालयों की किसी भी गतिविधि में यहां तक कि परीक्षाओं में भाग नहीं ले सकेगा। निलंबन की अवधि में विश्वविद्यालय छात्रावास के वार्डन उस छात्र को छात्रावास से भी नितम्बत या निष्काषित कर सकते हैं।
