एमबीएम इंजीनियरिंग कॉलेज एलुमनी एसोसिएशन, जोधपुर की कार्यकारी समिति की बैठक दिनांक 28.05.2022 को एसोसिएशन कार्यालय में संपन्न हुई। इसमें बाड़मेर और जालोर जिले के सभी कॉलेजों को नव निर्मित एमबीएम विश्वविद्यालय जोधपुर से संबद्ध करने के राजस्थान सरकार के निर्णय की कड़ी निंदा का प्रस्ताव पारित किया गया है।


Sir,

By above Gazette notification dated 19 May 2022 Government has transferred all colleges of Barmer and Jalore districts to MBM University from JNV University Jodhpur.


The above notification will not only Ruin the JNV University but also kill the very sprite of creating the MBM University.

We therefore humbly request you to kindly immediately revoke the above order.



उपर्युक्त विषयान्तर्गत निवेदन है जयनारायण व्यास विश्वविद्यालय पहले से ही आर्थिक संकट का सामना कर रहा है और ऐसे में बाड़मेर एवं जालौर जिले के संबंधित कॉलेज एमबीएम विश्वविद्यालय के अधीन कर दिए जाने से आय के स्रोत क्षीण हो गये हैं। यह विश्वविद्यालय केवल राजकीय सहायता पर आश्रित है जो राज्य वित्त पोषित विश्वविद्यालय अपनी गतिविधियों का संचालन करता है जिसमें से करीब 80 करोड़ रुपए विश्वविद्यालय के पेंशनर्स भुगतान के लिए आवश्यकता होती है।

साथ ही जयनारायण व्यास विश्वविद्यालय की पेंशनर्स सोसाइटी ने भी इस सम्बंध में निवेदन किया है कि इस निर्णय पर पुनर्विचार करके विश्वविद्यालय को आर्थिक संकट से बचाया जाए तथा विश्वविद्यालयों के पेंशनर्स राजकीय वित्त कोषालय, ट्रेजरी से पेंशन भुगतान के भी शीघ्र आदेश जारी करवाकर अनुग्रहित करावें।
