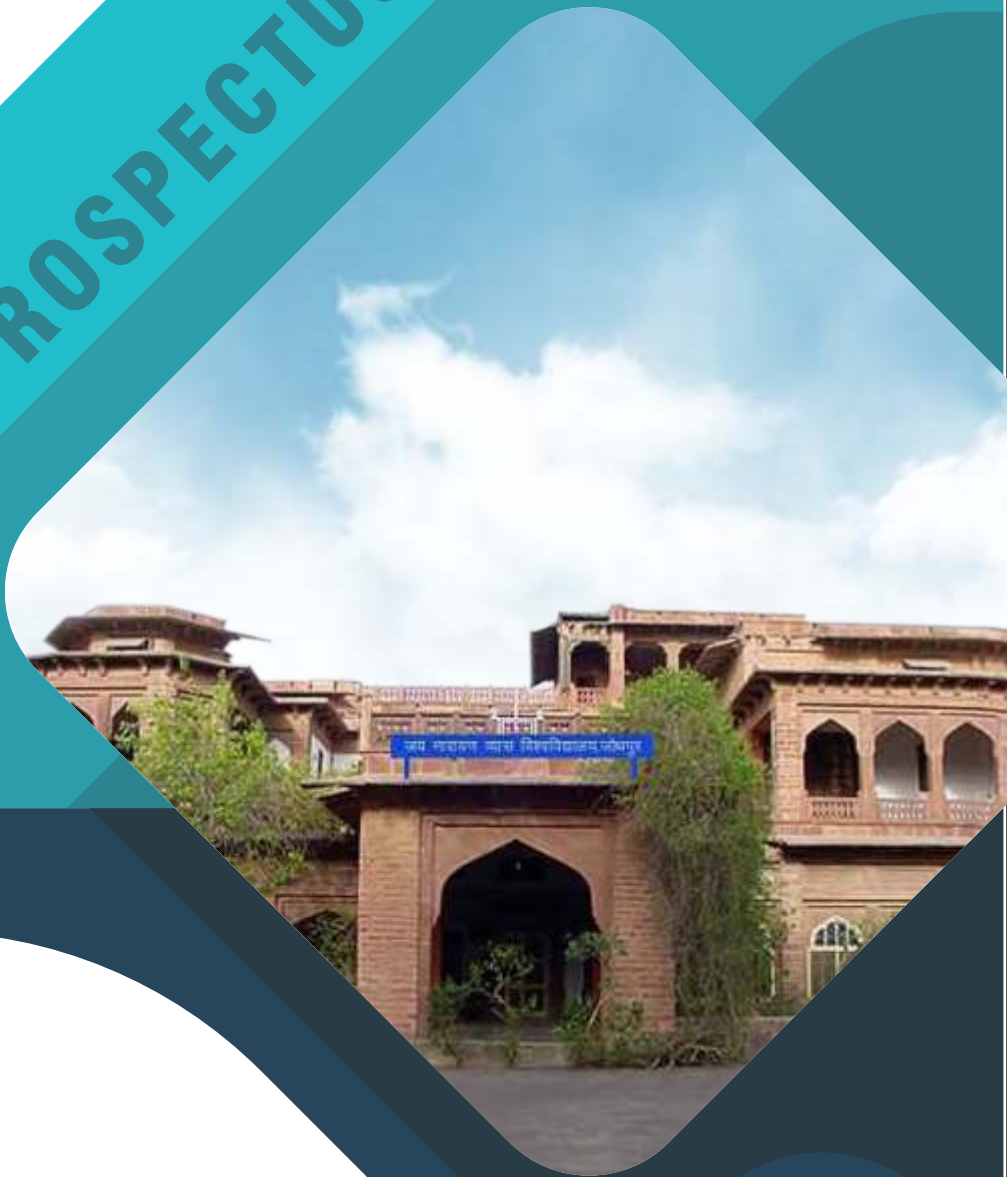

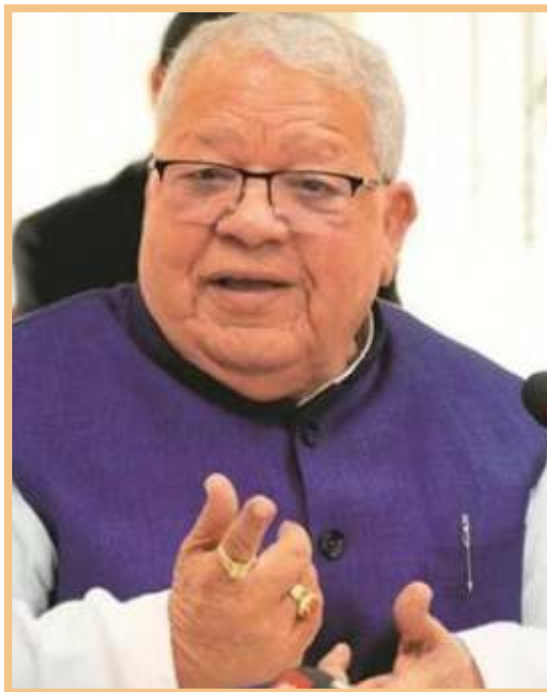

- In case of non-compliance of any of the requirements for admission including the non-submission of relevant documents and / or non-payment of fee within the prescribed date and time, the candidate will lose his / her right to admission.
- If at any stage the documents relating to the admission of a candidate are found to be fake / non-genuine or fabricated or in any other manner defective, the said candidate will not be admitted and if already admitted, admission will be cancelled without any prior notice in this regard. If the same is found after the completion of program, his / her degree will be cancelled and appropriate legal action will be taken against him / her.
- Prior to online registration, the candidates are advised to acquaint themselves with the University Statutes / Ordinances / Rules / Regulations / Syllabi. JAI NARAIN VYAS UNIVERSITY: AN INTRODUCTION

Jai Narain Vyas University, formerly known as University of Jodhpur was Established in 1962, and following four Government Colleges of Jodhpur became part of the University.

- I. MBM Engineering College (Now MBM University)
- II. Jaswant College (now Faculty of Commerce & Management Studies)
- III. S.M.K. College (now Faculty of Law and Campus of Institute of Evening Studies. This also houses Coaching Centre for Weaker Sections)
- IV. K.N. College for Women (The multi-faculty constituent college of the University).

Dr. S. Radhakrishnan, the President of India inaugurated the then University of Jodhpur on 24th August, 1962. In his inaugural address, the Hon'ble President revered Prof. Radha Krishnan desired and defined the goals and objective "That the young people, who will be educated in this university, will go forward not as prisoners of the past, but as pilgrims of the future; will develop in them a spirit of dedication, a spirit of renunciation, a spirit of whole-hearted, single-minded concentration on the advancement of the knowledge, whether in science or humanities."

This was the only residential University in the State of Rajasthan, catering mainly the needs of students of western Rajasthan (the Marwar). Since, this University is located in the great Indian Thar Desert, its R&D activities cantered on heritage, society and challenges of the region. This is the Western most University of the country and imparts education and conducts research in border areas neighbouring Pakistan. 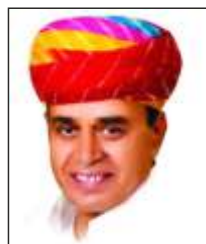

कला, शिक्षा एवं समाज विज्ञान संकाय

Brief About the Faculty: 14 जुलाई, 1962 को जोधपुर विश्वविद्यालय, जोधपुर (परिवर्तित नाम जय नारायण व्यास विश्वविश्वविद्यालय) की स्थापना के साथ ही पुराना परिसर स्थित श्री महाराजा कुमार कॉलेज को कला, शिक्षा एवं समाज विज्ञान संकाय के रूप में स्थापित किया गया। इस संकाय के संस्थापक अधिष्ठाता प्रसिद्ध इतिहासविद् प्रो. वी.पी. सक्सेना रहे। सन् 2017-18 से पूर्णतया भगत की कोठी, पाली रोड, स्थित नया परिसर में स्थित है। संकाय के अन्तर्गत स्नातक कक्षाओं का अध्यापन कार्य होता है। इसके लिए यू.जी. ब्लॉक नाम से अलग से समस्त आधारभूत सुविधाओं युक्त विस्तृत भवन है। स्नातकोत्तर विभागों व कक्षाओं के संचालन के लिए भाषा प्रकोष्ठ व समाज विज्ञान प्रकोष्ठ के नाम से अलग से विस्तृत भवन है। कला संकाय में निम्नलिखित 16 विभाग हैं- अर्थशास्त्र विभाग, अंग्रेजी विभाग, फाइन आर्ट्स विभाग, भूगोल विभाग, हिन्दी विभाग, इतिहास विभाग, पत्रकारिता एवं जनसंचार विभाग, दर्शनशास्त्र विभाग, राजनीति विज्ञान विभाग, मनोविज्ञान विभाग, राजस्थानी विभाग, संस्कृत विभाग, समाजशास्त्र विभाग, व शारीरिक शिक्षा विभाग इनके अतिरिक्त टेप्से एण्ड हेप्सन, डिफेन्स एण्ड स्ट्रैटेजिक अध्ययन केन्द्र, महिला अध्ययन केन्द्र, बी.एड प्रकोष्ठ, आदिवासी अध्ययन केन्द्र, मधुसूदन ओझा शोध प्रकोष्ठ, सावित्री बाई ज्योतिबा शोध पीठ, गाँधी अध्ययन केन्द्र, नेहरू अध्ययन केन्द्र, बौद्ध अध्ययन केन्द्र, राव चन्द्र सेन शोध पीठ, अज्ञेय पाण्डुलिपि संग्रहण शोध केन्द्र व थियेटर सेल भी हैं।

संकाय के पास भाषा प्रकोष्ठ, समाज विज्ञान प्रकोष्ठ व यू.जी. ब्लॉक के नाम से भव्य भवन है। यू.जी. ब्लॉक में 33 कक्षा कक्ष व भाषा प्रकोष्ठ में 36 कक्षा कक्ष हैं। इनके अतिरिक्त लोक प्रशासन विभाग का अलग से भवन है। भाषा प्रकोष्ठ व समाज विज्ञान प्रकोष्ठ में विभिन्न भागों के कार्यालय तथा भूगोल विभाग, संगीत विभाग व मनोविज्ञान विभागों की प्रयोगशालाएँ हैं। फाइन आर्ट्स विभाग अलग से न्यू प्रशासनिक भवन में संचालित है। शारीरिक शिक्षा विभाग पुराने परिसर में पृथक् से बना हुआ है जिसके अधीन खेल मैदान व अन्य सुविधाएँ उपलब्ध हैं। संकाय के पास 160 सीटों का वातानुकूलित सभागार है। सभी भवन आधारभूत सुविधाओं व फर्नीचर से युक्त हैं। संकाय के पास 10 स्मार्ट कक्ष हैं जिनमें अधिकांश में अत्याधुनिक तकनीकी से युक्त स्मार्ट बोर्ड है

ECONOMICS

The Department of Economics came into existence in 1954 as one of the major departments in the former S.M.K. (Govt.) College of Arts, Jodhpur. When Jodhpur University came into existence in 1962, the department grew fairly and steadily. The faculty members of the department have been contributing in the academic research and have earned laurels at regional and national level. The main thrust areas of research are Tribal Development, migration, urbanization, poverty, employment, infrastructure, agriculture, women studies, human resource development, tourism development and gender studies etc. The department is successfully running the undergraduate (B.A. Hons), Post Graduate and Ph. D. programs. The course content of the Economics syllabus of the department has been regularly revised to meet the NET/SLET requirement and prepares the students efficiently for various competitive examinations like civil service, banks etc. For evolving the research aptitude of the faculty members and students, national and regional seminars, conferences and workshops are organized by the department regularly. For the all-round personality

development of the students, extracurricular activities are also regularly organized in the department under the aegis of planning forum.

ENGLISH

Coming into being in 1962, the Department of English has brought frontier disciplines and newer perspectives for the old disciplines to the university system. We have the mode of instruction which encourages students to explore their own creativity and the exclusive internal evaluation and feedback from the students are adopted as an academic landscape. We at the Department of English, build up a content energetic endeavor grounded in an unorthodox academic system. The faculties of the department have many national and international publications. Many members of the department have won prestigious national and international awards for their academic work. The department brings out its own international referee/ research journal Jodhpur Studies in English which incorporates genuine and intellectual researchers. Thrust areas of the department are Linguistics, Grammar, Gender Studies, Trauma Studies ,Film Studies, American Literature, Indian English Literature, British literature, Caribbean Literature, Australia Literature, Canadian Literature and African Literature.

FINE ARTS AND PAINTING

Fine Art and painting as full-fledged Department was established in the Faculty of Arts, Education and Social Sciences in The Department introduced two academic courses, Master in Fine Arts and Painting in 2010 and the Bachelor of Fine arts and Painting in 1991. The Research Degree, Ph.D was started in the Department from 2014. At present we offer B.A. & M.A. in Painting and Ph.D in Fine Arts.

The teaching programme in the Department is focused on quality result in both Creative painting and Research. Periodic updating of syllabi in accordance with the relevance and advancement of knowledge of the subjects taught in the Department is done on a regular basis.

The thrust area of Post graduate course covers Ancient. Medieval, Modern and Post Modern studies and practices in Art.

The studio training comprises conventional art techniques such as wash, graphics, traditional crafts as well as modern emerging medium like creative and mix media painting landscape painting installation etc.

The research programme course the art history and criticism of Ancient. Medieval, Modern and Post Modern period while special attention is given to the contemporary and global trends relevant to Indian art

विश्वविद्यालय स्थापना वर्ष में ही हिंदी विभाग का संचालन प्रारंभ हुआ। हिंदी विभाग के प्रथम अध्यक्ष के रूप में शीर्षस्थ आलोचक तथा कवि डॉ. रामशंकर शुक्ल 'रसाल' की नियुक्ति हुई। हिंदी विभाग को भारत भारती पुरस्कार से सम्मानित प्रो. कुँवर चन्द्रप्रकाश सिंह और हिंदी के प्रख्यात आलोचक प्रो. नामवर सिंह की अध्यक्षता का सौभाग्य प्राप्त हुआ। महाकवि सच्चिदानंद हीरानंद वात्स्यायन 'अज्ञेय' का भी सक्रिय सहयोग विभाग को प्राप्त हुआ।

अज्ञेय पाण्डुलिपि एवं शोध संग्रहालय – हिन्दी विभाग द्वारा संचालित अज्ञेय पाण्डुलिपि एवं शोध संग्रहालय में नामचीन विद्वानों के हस्तलिखित पत्र संग्रहीत हैं। जिनमें हिंदी जगत के मूर्धन्य शिक्षक आलोचक प्रो. नामवर सिंह, अज्ञेय, कुँवर चन्द्र प्रकाश सिंह, मैनेजर पाण्डेय, सूर्यप्रसाद दीक्षित, जगदीश शर्मा के पत्र व्यवहार तत्कालीन हिंदी जगत के मान्य विद्वान जैनेन्द्र, अमृतराय, पंडित हजारी प्रसाद द्विवेदी, शिवमंगल सिंह सुमन, भीष्म साहनी, महादेवी वर्मा आदि प्रमुख विद्वानों के हस्तलिखित पत्रों का संग्रहण उपलब्ध है।

पुस्तकालय – हिन्दी विभाग का अपना एक समृद्ध पुस्तकालय है जिसमें विषय से संबंधित श्रेष्ठ एवं उपयोगी पुस्तकों का संकलन किया गया है। यह पुस्तकालय विभागीय सदस्यों, शोधार्थियों तथा स्नातकोत्तर स्तर के विद्यार्थियों हेतु उपयोग में लाया जाता है।

HISTORY

Department of History came into existence in 1962. Since then the department is making progress in leaps and bounds. The department offers undergraduate pass course, Honours, Masters, Diploma and certificate courses. Thrust area of the department is research in regional history. Department also has a Museum and Rao Chandrasen Shodh Peeth.

JOURNALISM AND MASS COMMUNICATION

जयनारायण व्यास विश्वविद्यालय जोधपुर की स्थापना (1962) के साथ ही हिन्दी विभाग के एम.ए पाठ्यक्रम में पत्रकारिता एवं जनसंचार एक विषय के रूप में आरम्भ हो गया था। जुलाई 1992 में हिन्दी विभाग के अन्तर्गत पत्रकारिता एवं जनसंचार विषय में पी.जी.डिप्लोमा के रूप में शुरुआत हुई। विषय की महत्ता को देखते हुए वर्ष 1992 में ही स्नातकोत्तर पाठ्यक्रम के रूप इसे स्वीकार कर लिया गया। 01 जून, 2012 से इसे पृथक विभाग

के रूप में मान्यता मिली । जिसके संस्थापक अध्यक्ष प्रोफेसर सत्यनारायण थे एवं वर्तमान में अध्यक्ष का कार्यभार प्रो. श्रवण कुमार मीना संभाल रहे हैं । विभाग के अन्तर्गत दो वर्षीय स्नातकोत्तर पाठ्यक्रम (एम.ए. पत्रकारिता एवं जनसंचार), तीन वर्षीय स्नातक पाठ्यक्रम (एक विषय के रूप में) तथा पत्रकारिता एवं जनसंचार में 03 वर्षीय स्नातक पाठ्यक्रम (स्ववित्तपोषित) का अध्यापन किया जा रहा है। इसके अतिरिक्त विभाग में पी.जी. डिप्लोमा इन रिपोर्टिंग, राईटिंग एण्ड एडिटिंग, पी.जी. डिप्लोमा इन एडवर्टाइजिंग एण्ड पब्लिक रिलेशन (एक वर्षीय), सर्टिफिकेट प्रोग्राम इन स्पोर्ट्स जर्नलिज्म (6 माह) स्ववित्तपोषित पाठ्यक्रम उपलब्ध है । विभाग में पत्रकारिता एवं जनसंचार विषय में पीएच.डी. उपाधि की भी सुविधा है ।

विभाग द्वारा 'उजास' नामक पत्र का सम्पादन किया जाता रहा है । देश के विभिन्न मीडिया चैनलों एवं प्रतिष्ठित पत्र-पत्रिकाओं में विभाग के विद्यार्थी अपनी सेवाएं दे रहे हैं ।

PHILOSOPHY

Before the establishment of Jodhpur University in 1962, the Department of 'Philosophy' was affiliated with Rajasthan University. With the establishment of the University, this department was accepted as a part of Jai Narain Vyas University, Jodhpur (formerly University of Jodhpur). Eminent scholars in this department like Prof. V.H. Dante, Prof. P.T. Raju, Prof. Baswara and Prof. Chandmal Sharma have given their services.

The Department of Philosophy was awarded the important 'Pranavananda-Puraskar' by the 'All India Darshana Parishad' in the year 1986.

A research journal 'The Journal of Philosophical Studies' has been published by the department. Which was successfully edited by Dr. Autar Lal Meena of the department.

Refresher courses, seminars, symposia and lectures have been organized by the department from time to time.

POLITICAL SCIENCE

Department of Political Science is a leading department in the Faculty of Arts, Education and Social Science since its inception in 1962. The teachers are actively engaged in research work supervising Ph.D. and D.Litt. scholars successfully. Faculty members publish research papers and articles in refereed journals and participate in National and International Conferences to keep them updated.

Prof. L. S. Rathore, former Head of the department is Political Scientist of International repute. He became Professor Emeritus and later on became the Vice-Chancellor of Jai Narain Vyas University, Jodhpur. The books authored by Prof. B.L. Fadia (retd.) are included as recommended readings in the syllabi of many Universities.

Four faculty members namely Prof. P.S. Bhati (retd), Prof. Anand Mathur (retd), Prof.

Poonam Bawa (Retd) and Prof. Kanta Kataria have so far been awarded D.Litt. in Political Science.

Thrust areas of the department are Political Theory, Indian Political System and Indian Political Thought

PSYCHOLOGY

Established independently as department of Psychology in the early 1960s by the committed efforts of Prof. Vasawada and nurtured by stalwarts like Prof. M.C. Joshi, a post-graduate from the Banaras Hindu University, who held a degree in A.M. from the world re-knowned University of Stanford.

The psychology laboratory is the oldest laboratory of Rajasthan and at one point the best testing laboratory of North India.

It boasted of possessing the first polygraph machine in Rajasthan. The department also possessed a biofeedback machine. JMPI(Jodhpur Multiphasic Personality Inventory) designed by Prof. M.C.Joshi and Prof. A.K. Malik was made compulsory in the Master's program in the whole of Madhya Pradesh. The department has Class Rooms, Smart Class Room and 2 UG and PG Lab, 250 plus standardized psychometric tools (Indian and Foreign) in English and Hindi. Approximately 50 instruments.

TEPSE HEPSN : It was inaugurated by the Ex- Governor Mrs. Pratibha Devi Singh Patil and ex-president of India on 15th July, 2006 It was initiated by Professor Ravi K Gunthey, and was the first one of its kind, special school run by a University in the whole of North India. Currently TEPSE & HEPSN Centre is operating with ten guest faculty members and one permanent faculty.

In the year 2016 TESPE & HEPSN organized a national conference on "Current Educational Perspective: Strategies and Intervention" And in the year of 2017 TEPSE & HEPSN organized on a very big scale an international conference on "Psychology Beyond Horizon"

PUBLIC ADMINISTRATION

The Department of Public Administration was established in 1997 in the university. Initially, the department was running along with the Department of Political Science. In the year 2003, Public Administration was established as an independent department.

RAJASTHANI

राजस्थानी भाषा, साहित्य और संस्कृति के महत्व को समझते हुए उच्च शिक्षा और साहित्यिकी शोध कार्य को

बढ़ावा देने के लिए राजस्थान प्रदेश में सबसे पहले जय नारायण व्यास विश्वविद्यालय, जोधपुर में एक स्वतंत्र राजस्थानी भाषा विभाग की स्थापना सत्र 1974-75 हुई। जिसमें स्नातक स्तर की कक्षाएँ प्रारम्भ की गईं। जिसमें बड़े ही उत्साह और लगाव के साथ विद्यार्थियों ने प्रवेश लिया उसके बाद सत्र 1983-84 में इस विभाग में स्नातकोत्तर कक्षाओं को प्रारम्भ किया गया। तब से लेकर आज तक राजस्थानी विभाग में एम.ए. नियमित और स्वयंपाठी दोनों में विद्यार्थी बड़ी संख्या में प्रवेश ले रहे हैं। इसके बाद एम.फिल., डी.लिट., और पीएच.डी. और पीडीएफ. उपाधियों के कोर्स भी समयानुसार प्रारम्भ किये गए। राजस्थानी विषय की स्नातक स्तर की कक्षाएँ कला संकाय, कमला नेहरू महिला महाविद्यालय और सांयकालीन अध्ययन संस्थान में ली जाती हैं। विभाग की यह बहुत बड़ी उपलब्धि रही है कि इसकी स्थापना से लेकर आज तक जितने प्राध्यापकगणों ने यहां पर अध्यापन का कार्य किया उन्होंने अपने तन मन और धन से इस विभाग को समृद्ध बनाने में महत्वपूर्ण योगदान दिया।

SOCIOLOGY

Department of Sociology was established in the year 1963 with Post – Graduation program of studies Prof. K.S. Srivastav was the first Head of the Department. The Faculty of Law was established in 1946 with a vision of creating the best of legal executives, practitioners, Judicial officers, corporate advisors, Civil Servants and Academicians and also, for the advancement of learning, teaching, research and diffusion of knowledge in the field of law.

The students here are groomed for bright professional careers by providing wide range of exposure on theoretical as well as practical concepts of Law. The Law faculty has a well-qualified, experienced and committed team of faculty members. The highly pragmatic and progressive environment developed of learning, enhancement of knowledge and skill. The Faculty is making all efforts to see that the students are given legal education to successfully compete in the large avenues open to them. As such, the programmes are tailored accordingly from time to time. Law faculty is always concerned with the all-around development of the students and has made available to them, all the necessary facilities and amenities to become worthy citizens of India.

In the Faculty, along with the Dean, one Professor and seven Assistant Professors are working. The Faculty offers admission in B.A./B.B.A. LL.B. (Five Year Integrated Law Programmes), LL.B. (Three Year Degree Programme), LL.M. (Two Year Degree Programme), P.G. Diploma in Labour Law, P.G. Diploma in Legal and Forensic Science, etc. 52 Research Scholars, 2 Post-Doctoral Fellowship holders and 3 JRF/SRF holders are pursuing research in the Faculty. Classes of graduation in Law began in the academic session 1947-48 in Jaswant College established in the year 1983 in the memory of His Highness Jaswant Singh of Marwar. Prof. Shreechand Thanvi was appointed as the Head of the Department along with Senior Advocate Professor by the then Public Service Commission of Jodhpur for teaching of Law.

Till 1967, according to Advocates Act and Bar Council of India, the degree of Law graduation was conferred on passing examinations after completing two years of Law programme. Since 1967-68, Three Year degree programme was started in the Law Faculty of Jodhpur University. P.G. Diploma in Labour Law began in 1964. Besides, other Diploma programmes were also offered and since 2010-11, Five Year Integrated Programmes of B.A. LL.B. & B.B.A. LL.B. have been commenced. The first Doctoral degree of Doctor of Philosophy was conferred in 1972. In 1995, Dr. Kailash Chandra Daiya was awarded the Degree of LL.D.

The Academic Seminars, United Nation's General Assembly Model Session, Refresher programmes for faculties, Moot Court competitions etc. are being organized by the Faculty on regular basis. Legal service committee of the Law Faculty, in Co-ordination and co-operation of teachers and students, every year organizes Legal Literacy and Service Camps in rural areas to enable students to realize their responsibility towards society. Teachers of Faculty of Law have participated in various national and international seminars and various conferences. Students of Faculty have shown active participation in academic/curricular and co-curricular activities at national and international level.

Legal Luminaries like Dr. Dalveer Bhandari, Dr. Prakash Chand Tatiya, Dr. Ganpat Singh Singhvi, Dr. Ashok Mathur, Dr. Rajendra Mal Lodha, etc. luminaries have pursued their studies from the Faculty of Law and have brought for the University and the Faculty of Law in

various areas/fields in India as well as abroad. Our current Chief Minister of Rajasthan, Shri Ashok Gehlot and Jodhpur's current M.P. Shri Gajendra Singh Shekhawat are also alumni of the Faculty.

For the development of the Faculty, there is a constant endeavour to include new sources for strengthening, consolidation and enhancement of the programmes of law, to make legal education an apt means for acquiring justice through lawful means, to produce brilliant and legally competent students for international as well as national level as Advocates, Judges, Legal Counsellors and Law educators, to employ latest technology for education of law, to use legal surveys, etc. for education of law, and to make social legal research useful for society and the nation.

In the Faculty, all the books pertaining to various law subjects are available in the Law Library. Faculty publishes Indian Journal of Legal Studies. There is a computer lab having 10 computers, available for the teaching and convenience of students. Faculty has an equipped experimental laboratory for the students of PGDCLFsc. The faculty is generally a green campus.

- **Classrooms:** The Faculty of Law has 30 well-equipped classrooms where lectures, discussions, and interactive sessions are conducted. These classrooms provide a conducive learning environment for students.

FACULTY OF SCIENCE

The Faculty of Science was instituted in 1962. The faculty was then relocated to the new campus in the year 1971-72. The faculty comprises seven departments viz., Botany, Chemistry, Geology, Home Science, Mathematics and Statistics, Physics and Zoology. The faculty offers varied courses in undergraduate, post-graduate and research work in all the departments. The faculty has streamlined itself and embraced the CBCS pattern and semester examination schemes since 2015-16, the BCA and Pharmacy courses are also operational in the faculty on a self-finance basis.

There are 53 Classrooms, 14 Seminar Halls, Equipped Laboratories, Girls' common room, Well Stocked Departmental Libraries, Campus under CCTV supervision & Wi-Fi enabled campus. It has a conference hall with a seating capacity of about 150 students at its disposal for the smooth functioning of various academic activities including seminars, symposia, workshops and conferences. The faculty has its own Volley Ball, Basketball and Cricket ground and is used by the students and faculty members alike. An indoor stadium (table tennis and badminton court) with a gymnasium is also functional in the faculty. Prof. Ramjeevan Sengwa, Department of Physics has made his University proud on the world stage by making his high quality research and publishing it in eminent journals in top 1% of world's top 2% Scientist Ranking Year 2021.

MATHEMATICS AND STATISTICS

The Department of Mathematics was established in 1962 with the inception of the University.. The Department has been engaged in teaching under-graduate and post-graduate course in Mathematics since then. The graduate teaching in Statistics started in 1989 and the teaching of post graduate courses in Statistics began in 1989. The Department had also run M.Phil. Programme in Mathematics since 1988 the Computer Laboratory under the COSIST Programme.

The Department has been engaged in research in both Pure and Applied Mathematics and Statistics. The Department has produced 5 D.S.D.Sc.s and more than 120 Ph.D.'s. The Department has published in journals of national and international repute more than 1550 research papers.

Thrust areas of research are Special Functions, Fractional Calculus, Generalized Functions, Integrals Transforms, Differential and Integral Equations, Operations Research, Fluid Mechanics, Magneto hydrodynamics, and Plasma Dynamics. In Statistics, the research being carried out in the area of Sample Surveys, Statistical Distributions, Applications of Distributions in Demographic Studies, and Educational Statistics.

The Department is proud of recalling Mathematicians Prof. S. Saran, Prof. H.M. Srivastava,

Prof. K.M. Srivastava, Prof. B.R.K. Kashyap, Prof. S.C. Rajvanshi, Prof. C.M. Joshi, Prof. J.P. Singhal, Prof. R.C. Sharma, Prof. B.L. Sharma, Prof. J.L. Bansal, Prof. P.N. Rathie, Prof. P.C. Munot, Prof. S.L. Kalla, Prof. K.N. Gaur, and many others who had initiated research in various fields of Mathematics in this department and carved the name of the department on the academic landscape of India and abroad.

The Department has well equipped Library, Smart Classroom, Seminar Hall, a well-equipped computational Laboratory and one Statistical Laboratory.

Thrust areas of research are Special Functions, Fractional Calculus, Generalized Functions, Integrals Transforms, Differential and Integral Equations, Operations Research, Fluid Mechanics, Magneto hydrodynamics, and Plasma Dynamics. In Statistics, the research being carried out in the area of Sample Surveys, Statistical Distributions, Applications of Distributions in Demographic Studies, and Educational Statistics.

BOTANY

The Department of Botany, was established in 1948 at Jaswant Campus and shifted to the New Campus in 1962. The Department of Botany has a strong foundation laid by the stalwarts: Prof. U. N. Chatterjee (Plant Physiology), Prof. H. C. Arya (Plant Pathology and Plant tissue culture), Prof. M.M. Bhardari (Taxonomy) Prof. Narendra Sankhla (Plant Physiology), Prof. David N. Sen (Desert Ecology), Prof. B. D. Sharma (Palaeobotany) and continuously nurtured by their disciples.

This department has made impressive progress in research and teaching activities from the last 70 years. Students and Researchers work for their Ph.D. and D.Sc. degrees in the Department of Botany. About eight laboratories are actively engaged in different areas of plant. Well-equipped smart class-rooms are available for teaching. The research and development activities attract national and international attention. Research and Development projects are funded by national and international agencies. These include, the European Economic Community, FAO, UNDP/UNIDO, US-PL-480, CSIR, UGC, DST, DBT, DRDO, DOEn, ICAR, ICFRE, CSB, Ministry of Health, State DST, etc.

The department possesses good infrastructure and modern equipment required for teaching and research. The department has amenities such as Smart Classrooms with Interactive Flat Panels (IFPs), CCTV Surveillance, Botanical Garden and Herbarium. Slide/Overhead Projectors/Multimedia System/ Smart Board

The Departmental library has enriched to latest books and high impact factor Journals. The existing high-speed internet facility in library also provided basic platform to post-graduate students, research scholars and faculty members.

ZOOLOGY

The Postgraduate Department of Zoology came into existence in 1963 after the establishment of University of Jodhpur in 1962. However, the root of this department goes back to 1948 in the erstwhile Jaswant College, a premier institution of Rajasthan at that time. Officially Zoology department has been functioning under the university structure for the last 52 years. This period was full of events, achievements and growth in terms of student intake, teaching faculty, research projects, publications and research grants. The department is fortunate in having Professor Vishwanath, Sc.D. FNA at its founder head in 1963. Four members of this department have been elevated as Vice-Chancellors of reputed universities.

Research scholars are working in the areas of physiology, ecophysiology, toxicology, ecology, animal behavior, environmental biology, radiation biology, cell biology, entomology and taxonomy, parasitology, fish biology and limnology, bioinformatics, primate behavior and wildlife conservation, palaeozoology etc. This department successfully carried out over 60 minor and major research projects funded by the UGC, CSIR, ICAR, DST, ICMR, DOE, DBT and other funding agencies. Presently, the department is having UGC - DRS (SAP) program. The department is enriched with Smart classrooms, Seminar room, M.Sc laboratory and , and undergraduate laboratories, well-maintained museum. Library enriched with more than 5000 books and journals, common instrument room, AnimalHouse, Field station, Fisheries hatchery unit, office unit and girls common room

CHEMISTRY

The Department of Chemistry is one of the founder departments of the Jai Narain Vyas University, Jodhpur, (Erstwhile Jodhpur University) established in July 1962. It imparts all levels of higher education, i.e. undergraduate, postgraduate, research degree and D.Sc. as well. UGC formulated a programme; COSIST and sanctioned the same to the department in

1983 for post graduate and development of research facility in the department. The M.Sc. course under this new scheme was operational between July 1985-2003.

The Department is amongst the very few in the country, which was selected for this programme. On the lines of COSIST University Department of Chemistry was identified by U.G.C. under Special Assistance Program (SAP) of Departmental Research Support under which autonomy has been assigned to the PG course in the Department of Chemistry since year 2010. Department of Chemistry is again identified by U.G.C. under Special Assistance Program of Departmental Research Support (DRS-II) for the period 2018-2023. The major thrust areas of the department are Environmental Chemistry and Solar energy conversion technologies

Pharmacy course came into existence in the year 2017 under the Dept. of Chemistry, Faculty of Science (JNVU). It offers 4 year degree course (B.Pharm) and 2 year diploma course (D.Pharm)

Thrust Area : Photo Chemistry, Phyto Chemistry, Applied Chemistry, Environmental Chemistry, Heterocyclic Synthesis, Coordination Chemistry

GEOLOGY

The Department of Geology had its beginning to teach only undergraduate classes in M.B.M. Engineering College (BE Civil and BE Mining) Later it became part of the Faculty of Science, in the year 1978 to teach B.Sc. In the year 1988, postgraduate program started. The department also offers Ph. D. & D. Sc. programs. The Department has basic laboratories of major areas of Economic Geology, Hydrogeology, Palaeobiology, Remote Sensing, Sedimentology, Igneous and Metamorphic Petrology for teaching and research. The students are given field training in geological mapping, rocks identification, mineral exploration, and Stratigraphy, from ten to fourteen days in even semesters. The department is enriched with smart classrooms, Seminar Hall, Laboratories, Museum and classrooms

Thrust Areas:

Palaeontology, Economic Geology, Hydrogeology and Sedimentology.

PHYSICS

The Department of Physics was established in the year 1962 in Science Faculty, New Campus. Since then the Department has flourished under the guidance of renowned physicist and researchers. The faculty members are making continuous efforts to further enhance the teaching and research activities in the department.

The major research areas in which the department has contributed remarkably are: Dielectric Spectroscopy, Polymer Physics, Solid Polymer Electrolytes, Nanodielectrics, Organic Semiconductors, Mossbauer Spectroscopy, Atomic and Molecular Spectroscopy, Multiferroic, Superconductors, Quantum Optics, Atomic Physics, Computational Materials Sciences, Theoretical Solid State Physics and X-Ray Spectroscopy.

The department is equipped with XRD, High Energy Planetary Ball Mill, Computational Facilities, Mossbauer Spectroscopy, Dielectric Spectroscopy, UV-Vis Photoluminescence analyzer, Impedance analyzer.

The department is conducting B. Sc. Regular Course in Physics and Electronics, M. Sc. Physics Semester Course with CBCS and Ph. D. Course.

The department has been continuously receiving grants from the government funding agencies for development of infrastructure and research facilities. The recent funds received are DST-FIST grant, UGC-SAP DRS level-I and level-II grant, Major projects from UGC and DST granted to individual researchers and research fellowship to the students under UGC-BSR scheme. In recent years many students qualified the prestigious national level exams such as NET-JRF and GATE etc.

The department has published more than 300 research papers in various International and National research journals of high impact factor during last one decade. The faculty members have been nominated as member of the editorial board of various International Journals. Post doctoral students from our department have been awarded Young Scientist project of SERB-DST and Research Associateship of CSIR.

HOME SCIENCE

Home Science as a field of Education is more of women oriented, preparing women for playing multifarious roles such as professional career women, an enlightened homemaker and awakened community worker.

Infrastructural Facilities

The Infrastructural Facilities available in UG (K.N.C.W.) area contain four class room fully equipped with LED Projector and OHP Projector, four laboratory (fully equipped with various apparatus), one computer room for office and Academic work. (Carpet area approx. 60X120 Fit. Double story)

In PG (New Campus) area contain seven class room fully equipped with LED Projector and OHP Projector, Four fully equipped laboratory and Seminar room, Office room with computer facility and One HOD Room. The Department is surrounded by CCTV Surveillance for safety purpose of the Girls candidates and the building. (Carpet area approx. 100X100 Fit.)

UNIVERSITY SCIENCE INSTRUMENTATION CENTRE (USIC) COMPUTER SECTION, USIC

The Computer Section, USIC, faculty of Science runs Bachelor of Computer Applications (BCA) since 2010 and Master of Computer Applications (MCA) (the MCA course is running in JNV University since 1988). The Computer Section is well equipped with computer laboratory and the USIC building is Wi-Fi. The BCA course runs in self-financing (SFS) mode with 69 seats and the MCA course is a GAS course with 35 seats. The section is well-equipped with Computer Laboratories- each laboratory is equipped with computers, printer and Projector. Each computer is having latest software and Internet facility, Digital and Microprocessor lab

ELIGIBILITY CRITERIA FOR ADMISSION

The procedure to be followed for fresh admission in general faculties for the session 2023-2024 is given in Annexure-II

Girl students be admitted up to the minimum percentage, i.e. 36% if seats are available in Girls Colleges. This rule is applicable for all Girls Colleges as per State Government rules.

Relaxation of 5% marks in the admission is granted, if seats are vacant in Undergraduate and Postgraduate classes in all the faculties.

NOTE:

The candidates who are seeking admissions in B.A./ B.Com. /B.Sc. Part I, postgraduate previous level, LL.B. /LL.M. and P.G. Diploma courses should submit his/her original marks-sheets and other relevant documents in original at the time of depositing the hard copy of the form and final admission fee challan.

After verification of the original documents, if any information furnished by the candidate in admission form, on which candidate got admission, is wrong or mismatched, then his/her admission will be treated as cancelled and fee deposited will not be refunded.

The provisional admission will be given to the students with supplementary in the qualifying examinations in all streams till the outcome of the final results is received.

If a candidate opt to withdraw from the program of study in which he/she is enrolled, fees will be refunded as per provisions laid down in sub para 4.2.3 of para 4.2 under the heading Remittance and Refund of Fees of UGC Notification D.O.No.1-3/2007/(CPP-II) dated 6.12.2016.

In case of upgradation from SFS to GAS fees will be refunded as per Notification issued by the University from time to time.

Continuity fees of provisionally admitted students in next higher class will be refunded as per rules at the earliest, if he/she fails in the previous class and claimed by the student.

Last date up to which pending application for want of marks-sheet and the cases of those students who have passed qualifying examinations from Rajasthan Board / CBSE or any other board for admission to be finalised is **31.8.2023**. Last date for submission of Migration Certificate is **31.7.2023**.

For the programs running under old scheme, which are governed by NCTE, PCI, BCI and RCI the last date will be Sep.30, 2023. No candidate will be admitted after expiry of prescribed dates. Admission means the deposition of fees by the candidate on proper authorisation.

The last date for admission of candidates who pass examination of this University as a result of re-evaluation/supplementary examination etc.will be as follows:

(i) The candidates exonerated from unfair-means and passing examinations as a result of re-evaluation shall take admission within 10 days from the date of declaration of decision/result. But in other cases except-mentioned above no admission shall be granted after **30th September, 2023 old scheme**. Admission in the higher class will be provisionally given. The candidates will not be granted admission in the subject in which he has been declared eligible for supplementary examination. The merit of such students will be decided by counting minimum pass marks in the subject of supplementary examinations.

(ii) Subject to the availability of seats and subject to condition of merit, the cases of such candidates who have passed Senior Higher Secondary Examination (10+2) Scheme in scrutiny at the Board of Secondary Education Ajmer may be considered if they have applied for admission within 10 days from the date of declaration of re-evaluation results.

(iii) A candidate who has passed in supplementary or as a result of re-evaluation will be admitted only if his/her marks are not less than the marks of the last candidate admitted.

(a) All admissions shall be made strictly on percentage basis, following the reservation rules as laid down by the state government. However, for the allocation of subjects, it was agreed that admission may be given to all the candidates as per their choice and if any choice is not met with them it may be left blank to be filled by the student through counselling in the respective institute/faculty/college on the day and time decided by the institute/faculty/college.

Fee challan will be generated according to the subject allotted and for blank subjects, fee will be charged as a non-practical subject where practical's are opted for, difference in fees if any including that of practical subjects/S.F.S. scheme will be charged by the institute/college/faculty according to the subject allotted. **Subject(s) chosen by the students be mentioned in the challan.**

(b) In the case of postgraduate classes, the admission list, together with the waiting list, containing all the names of candidates in the main list shall be put on the notice board/web site.

(c) Change of optional/special papers at the undergraduate and postgraduate level will be permitted as per the ordinance and rules of NEP in the stipulated period through Local Credit Monitoring committee.

ADMISSION ON TRANSFER OF PARENTS

(i) The students who had taken admission in the college/University at the places from where there parents have been transferred and who are subsequently admitted in this University, their attendance at the previous college/university will be counted towards their total attendance in this University.

(ii) The admission application forms of such of the students who themselves or whose parents and employees of the State Government or of the Central Govt. or of the Autonomous Bodies and who have been transferred and posted in Jodhpur, be accepted

within 10 days from the date of joining of duty in Jodhpur or 30.11.2023 (old scheme), whichever is earlier. Such candidates be admitted only if they have obtained marks not less than the last candidate already admitted in the respective category. The Candidates admitted in various programs under NEP the last date will be within 10 days of joining the service in Jodhpur or 31.07.2023 whichever is earlier.

Commencement of Classes: The Regular classes for all the programmes will commence from July 01, 2023 for all UG classes. Second year/Third Year Degree Classes and Final Year of Post-Graduate classes will start functioning on the basis of provisional admission. Those candidates who fail to pass the qualifying examination would be dropped. The candidates/qualifying for supplementary examination will be given provisional admission in the next higher class of the continuing course. Publicity be given through newspapers/web site regarding admission.

For continuing students, a notification be issued requiring them to fill up the continuity form online as per the order of the Vice Chancellor. This will also apply to those regular students who have passed the lower examination in 2023. Ex-students and those with break in continuity should apply like fresh students.

The seats reserved for physically challenged students be filled by such students as are eligible in order of merit to be determined amongst them only. If a physically challenged student is admitted against the general quota on his own merit, his admission shall not be counted towards reservation quota.

(A) The price of online Admission Application Form for fresh students be fixed at Rs.400/- and continuing students be fixed at Rs. 400/- each. Suchna Pustika be also available online with Admission online Application Form.

(B) The candidates who wish to apply for admission to more than one undergraduate class or postgraduate class or P.G. Diploma Course in a faculty shall submit separate application forms.

(C) The detailed guidelines to be followed for admission with regard to registration of forms received, preparation of merit list, display of merit list, calling of candidates for admission with original challan of fee etc. will be issued separately.

In order to sort out the problems pertaining to admission of students to various classes in the University during the session 2023-2024 a committee of Deans, Faculty of Arts, Science, Commerce, Law and Directors, K.N. College for Women and IES shall be constituted. Those representation which may be directly received by the Vice-Chancellor/Registrar will first be sent to the Head of the Department concerned/Dean and after their comments, the representation be put up to the Central Admission Committee. The senior most Dean shall be the Convener of this Committee. The Committee shall meet as often as necessary. The Deans of the Faculties, the Directors of KNCW/IES and the Principals of the Affiliated Colleges, the Heads of Depts. may refer to the above committee any problem that they may face in the course of implementation of decisions of the Admission Board. In no case committee shall deviate from the decisions of the Admission Board taken regarding admissions.

The dates for admission to regular B.Ed. Course shall be same as decided by the State Level Admission Committee and conveyed by the PTET.
B.Ed. (Regular) 200 seats.

PROCEDURE TO BE FOLLOWED FOR FRESH ADMISSIONS IN GENERAL FACULTIES FOR THE SESSION 2023-2024.

1. The candidates seeking fresh admission shall be required to submit the online application form available on the web sites www.jnvu.edu.in
2. The hard copy (down loaded copy) of the application form submitted by the candidate with bank challan and relevant self attested documents will be received by the office of the Faculty/College/Institute concerned **only after securing his/her name in the merit list for admission and he/she will be given a receipt for it.**
3. **Only those candidates securing their names in the provisional online merit list (published) online and displayed on Notice Board in the concerned Faculty/College/Institute shall have to deposit hard copy along with application fee receipt and all the relevant self attested documents within 5 working days from publication of merit list.**
4. The application form so received will be checked by admission incharge, verified online and the verification number be recorded.
5. On the last date for submission of the forms with late fee, the online verifications shall be completed on the same date by the incharge and a printout of verified forms must be taken and filed properly.
6. Admission of the applicants failing to submit the hard copy with all relevant documents within stipulated time shall not be considered further.
7. The online marks sheet of qualifying examination will be accepted but candidate has to submit original mark sheet at the time of final admission otherwise his/her admission will be treated as cancelled and fee deposited will not be refunded.
8. The forms will be arranged in order of merit. The entries will be checked by the admission committee on the basis of the admission rules. The actual merit list prepared and checked by the Admission Committee/Admission Incharge shall be confirmed online.
9. On the basis of the available seats the merit list will be published online/on the Notice Board latest by two working days after the last date for submission of the hard copy. The percentage/category of each candidate will be mentioned.
10. After the publication of the above merit list the candidate will download the challan available online and deposit the fee. **The last date for depositing the fees will be the 07 clear working days from the date of notifying the merit list. Fine for not depositing fee in time Rs. 300/- per day upto maximum 3 days.**
11. After depositing the fee, the candidate will submit the copy of the bank challan with required original documents. On the basis of this, his/her name will be included in the list of the candidate finally admitted. The section will be formed out of this list.
12. The office will prepare class-wise and section-wise lists indicating the Faculty/College/Institute number allotted to the admitted candidates.

RULES FOR ADMISSION IN JNVU 2023-2024**1. CRITERIA FOR ADMISSION TO DEGREE COURSES IN THE FACULTY OF ARTS, COMMERCE AND SCIENCE**

2. ELIGIBILITY FOR ADMISSION TO DEGREE COURSES IN THE DIFFERENT FACULTIES

Commerce	45% marks in the aggregate at the qualifying examination. In the case of IES, 40% marks in the aggregate at the qualifying examination.
BBA	50% marks in the aggregate at the qualifying examination.
B.Sc, B.Sc (Home Sc.)/ B.C.A.	48% marks in the aggregate at the qualifying examination.
B.A. Hons/ B.Com. Hons.	48% marks in the aggregate and 50% marks in elective subject in which the student admitted for Hons.

Note:

- Admission shall be made on the basis of merit, subject to the availability of seats and subject to fulfilment of the conditions laid down by the University for the purpose from time to time.
- In determining merit of supplementary candidates, the minimum pass marks (Theory and Practical marks taken together) required to pass the supplementary examination shall be taken into consideration and not the actual marks obtained by the candidate.
- The following rules shall not apply in case of admission to the Institute of Evening Studies.

"No student with a third division shall be admitted if two or more than two years (Academic Sessions) have elapsed since he/she passed his last qualifying examination."
- Transfer of candidates from local colleges shall not be permitted in the I, II and III Year Classes of Degree Courses in any of the Faculties/Colleges.

5. For B.Sc. admission separate merit list be prepared for Biological Science stream and Physical Science stream.

3. ADMISSION TO FAILURES

Seats up to five per cent of the sanctioned strength of a class may be reserved for failures of the same institution subject to the following conditions :

- (i) A candidate who failed to appear at the examination without any valid/genuine reason will not be admitted.
- (ii) A candidate failing in all the optional/core subjects shall not be admitted to the same class in the same faculty.
- (iii) A candidate who has failed for two years in the same class shall not be admitted to the same class in the same faculty.
- (iv) A candidate who failed in one year and did not take the examination in the subsequent year on any ground, whatsoever, shall be treated at par with a candidate failing for two years.

RULES FOR ADMISSION IN THE FACULTIES OF ARTS, COMMERCE AND SCIENCE TO POSTGRADUATE CLASSES

1. CRITERIA

Admission in Postgraduate Classes will be regulated by the following rules:

* The above rules shall not be applicable in the Programs where the admission is given through entrance examination.

2. ELIGIBILITY FOR ADMISSION TO P.G. CLASSES

Qualifying Bachelor's Degree* in all Faculties:

- (a) B.Sc. in the subject concerned for the purpose of admission to M.Sc. class.
- (b) B.Com./B.B.A./B.A. with Economics with at least 55% marks in aggregate for the purpose of admission to M.Com. Class, but in case of admission to M.Com (Accounting), B.A. or B.Sc. even with Economics will not be eligible.

- (c) B.A./B.Com./B.Sc. for the purpose of admission to M.A. Class.
- (d) B.E./M.B.B.S. for the purpose of Admission to M.A. Class.
- (e) There will be centralized spot admission for P.G. courses in all the Faculties. The Fee will be deposited on the Spot at the time of admission. The spot admission shall be scheduled on the date decided by Dean of the concerned Faculties. The schedule of the counselling will be notified well in advance. P.G. Admission Committee in association with Head of the Departments will be responsible for the entire admission process.

Note: "The qualifying Bachelor's Degree" will mean B.A./B.Com./ B.Sc./BBA/BCA degree of this University or any other University recognised as equivalent to the Bachelor's degree of this University.

3. DETERMINATION OF MERIT

(i) Admission to same faculty:

(a) Admission to the Postgraduate classes in all Faculties shall be made on the basis of merit which shall be determined as below:

The total marks (both for Theory and Practicals, if applicable) obtained by a candidate at the 1st year, 2nd year and 3rd year examination in the subject in which admission is sought will be added to the aggregate marks obtained by him /her in all the subjects (which are considered for awarding a division) and the percentage of marks arrived at accordingly.

(ii) Admission to another faculty:

For inter-faculty transfer of the candidate not more than ten per cent seats will be reserved, if candidates seeking admission are eligible as per University rules. A separate merit list will be prepared for the candidates securing 55 per cent or more marks in the aggregate at the undergraduate level, a relaxation upto 48 per cent will be given if the vacancy exists. These candidates be admitted provided their percentage of marks is at par with the last candidate admitted in general category.

4. LOCAL BENEFIT FOR CANDIDATES OF JNV UNIVERSITY.

A benefit of 5 percent of the total aggregate marks obtained at the Degree examination shall be given to candidates passing their Degree examination from Jai Narain Vyas University, Jodhpur.

- 5. If a candidate re-appears at the B.A./B.Com./B.Sc. Examination and improves his performance, the higher marks will be taken into consideration for determination of his/her merit.
- 6. Candidates who have already postgraduate degree may be admitted to another postgraduate course on the basis of marks obtained at the degree examination.

7. Drop outs and failures will not be admitted to the same subject. However, such candidates may be considered for admission to other subjects on the basis of their merit at the degree examination.
8. A candidate who had two chances of admission to postgraduate classes or one P.G. and Law and had failed or dropped out or passed in both shall not be considered for admission to M.A., M.Com. and M.Sc.
9. Candidates getting supplementary will not be given admission to Postgraduate Course (Previous) in the subject in which they have to appear at the supplementary examination. Such candidates can, however, be considered for provisional admission to other subjects. While determining the merit of such candidates, the minimum pass marks required to pass in the supplementary examination shall be taken into consideration and the percentage will be worked out accordingly.
10. Candidates who have already passed Postgraduate degree may not be admitted into additional Specialisation in the same subject.
11. The private candidates of I year and II year of degree courses and M.A. (Previous) can be admitted as regular candidate in the next class provided that:

For admission to the II year as a regular candidate, the candidate must have secured 50% marks in the I year TDC.

For admission to III year as a regular candidate, the candidate must have secured 50% marks in the aggregate in I and II year.

For admission to Postgraduate final class as a regular candidate, candidate must have secured 55% marks at the postgraduate (Previous) examination.

The admission will be made on the following conditions:

- i. Admission of these candidates will be done only in the last partially filled section. No specialisation will be started at the post-graduate final level as a result of admission of these candidates.
 - ii. The admission of these candidates will be strictly on the basis of merit and availability of seats.
12. The candidates should also note the following:
 - O. 88. No candidate shall be allowed to appear for more than one degree or postgraduate examination at a time, diploma courses or proficiency course conducted by the University in any subject notwithstanding for which necessary instructions may be issued from time to time.
 - O.89. Candidates desirous of appearing at two examination of the University, i.e. at one full examination of the University as well as in additional optional subject of another University will not be permitted to appear at both the examinations simultaneously.

Note: The candidate taking admission in the Session 2023-24 as per NEP-2020 will be governed by the rules and ordinances passed under NEP-2020.

Admission of students to II year T.D.C.:

The admission of the candidates migrated from other Universities to B.A./B.Sc./B.Com. Part II be made directly by Dean/ Director/Principal conducted in compliance to Ord. 36 B(2) after taking remedial examination of deficiency paper(s) by the concerning Dean at their own level within two months from the admission of the candidate (Old Scheme).

ALL the above rules will be applicable to the admissions in the programs which are as per the old scheme (NEP is not applied)

For fresh admissions in UG and PG classes for the session 2023-2024 as per NEP-2020 rules and ordinances of National Education Policy will govern the entire admission Process. For these admissions as per NEP multiple entry and exit system will be in force.

Rules for Admission in the Faculty of Law

1. ELIGIBILITY FOR ADMISSION TO LL.B.

- (i) Subject to compliance with the requirements of the Ordinances and Regulations of the University, a candidate, who after taking the Bachelor's Degree in Arts/Science/Commerce/Medicine/Social Sciences/Engineering/Agriculture of this University or an Indian or Foreign University recognised for the purpose by the University and securing at least 45 percent marks in the aggregate shall be eligible for admission to the LL.B. Course.

Provided that not more than 20 percent of the total seats in LL.B. First Year shall be reserved for the candidates who will become eligible on the basis of Master's degree as defined above.

A candidate who has passed 10+2 qualifying examination with 50% marks shall be eligible for admission in B.A.LL.B./BBA LL.B. Courses.

- (ii) The Dean, Faculty of Law may permit admission to a migrating candidate to Second Examination in Law who has passed his First Examination in Law of any other University in India, recognised by the University under a scheme, which in essentials is the same, as the scheme of this University, on such terms and conditions as he may lay down.

The Dean, Faculty of Law, may permit admission to a migrating candidate to Final Examination in Law, who has passed his Second Examination in Law of any other University in India, recognised by the University under a scheme, which in essentials is the same as the scheme of this University, on such terms and conditions as he may lay down.

The Dean, Faculty of Law may permit admission to a migration candidate in B.A. L.L.B; B.B.A.L.L.B., who is pursuing L.L.B. five Years course approved by the Bar council of India in any other University. The admission may be given in the next semester to the semester in which the candidate has given the examination in other university subject to the condition that the candidate shall have to pass /backlog papers, prescribed by the syllabus of the Jai Narain Vyas University. The Dean may lay down the conditions and grant exemptions as he thinks fit.

EXPLANATION: If a candidate has passed some additional papers in other university, but which are not prescribed in the syllabus of Jai Narain Vyas University; such marks of additional subject shall not be counted in the final mark sheet to be issued by the Jai Narain Vyas University. On clearance of all the papers prescribed by the syllabus of Jai Narain Vyas University final mark sheet will be issued accordingly.

In the absence of the above rules, the migrating students, who want to get admission in Five Year Integrated Law Courses (B.A.LLB. and B.B.A. LLB.) will not get admission in the above course(s).

Besides this, Bar council of India has amended its rule w.e.f. 09.02.2014 regarding relaxation of marks to get admission Law Courses (TDC/FDC) for O.B.C. candidates. As per amendment only 3% marks may be given as relaxation to OBC Candidate as a result minimum percentage for O.B.C. will be 42%.

N.B: For the purpose of the above the marks of only those subject/papers shall be taken into account which had been considered for awarding division at the Bachelor's/Master's degree examination.

(ii) Admission to the LL.B. Classes will be regulated according to the following rules:

Note: When the entrance test is conducted in any programme, there will not be any rider of minimum 60 percent marks in the qualifying exams for candidates outside the State.

DETERMINATION OF MERIT

1. Marks obtained at the degree or postgraduate examination will be taken into account in preparing the merit list.
2. A benefit of 5 percent of the total aggregate marks obtained at the Degree or Postgraduate examination shall be given to candidates passing their qualifying examination from Jai Narain Vyas University, Jodhpur.
3. If a candidate re-appears at the B.A./B.Com./B.Sc. Examination and improved his performance, the higher marks will be taken into consideration to determine his merit.
4. Failures of LL.B. Class will not be given admission to the same class.

2. ELIGIBILITY FOR ADMISSION TO LL.M.

Subjects to compliance of the requirements of the Ordinances and Regulations of the University, a candidate who has passed the Bachelor of Laws Examination of this University or an examination of some other University recognised by the University as equivalent thereto shall be permitted to be admitted to the Master of Laws of this University through entrance test conducted by the Faculty of Law.

The Vice-Chancellor may, on the recommendation of the Dean, Faculty of Law, permit admission to migrating candidate to LL.M. (Part II), who has passed his LL.M. (Part I) Examination of any other University of the State of Rajasthan under a scheme which in essentials is the same as the scheme of this University on such terms and conditions as may lay down. Failures of LL.M. shall not be given admission to the same class.

ADMISSION RULES FOR MIGRANT STUDENTS IN LL.B.(TDC) B.A./B.B.A. LL.B. FIVE YEAR INTEGRATED COURSES.

Candidate will submit a declaration that no disciplinary action was ever taken against him by the institution where he studied in previous year(s) or semester(s). In support of his/her declaration, he/she will submit an affidavit on non-judicial stamp paper to this effect and a character certificate issued by the Head of the Institution previously attended.

Admission shall be given to migrant candidates only upto sixth semester in integrated Law courses and after that no admission shall be given to migrant candidates. In hard cases, admission may be given after sixth semester. The matter shall be placed before Departmental Council and Departmental Council shall decide for admission. Admission to migrant candidates shall also be subject to the conditions that his/her percentage of marks in senior secondary examination should not be less than the cut off percentage of last admitted student of that particular batch at initial level i.e. in First Semester.

This will also apply to LL.B. (Three Year Degree Course) with necessary modifications.

GENERAL RULES FOR ADMISSION IN JNVU

(Applicable to Faculties of Arts, Commerce and Science)

A. POWER TO REFUSE ADMISSION

The Deans/Directors/Heads of Departments/Principals shall have powers to refuse admission to a candidate in the following cases :

- (i) A candidate who has been guilty of gross misconduct, misbehaviour, etc. in previous years and/or guilty of misconduct during the University examinations for which disciplinary action has been taken against him.
- (ii) A candidate against whom a criminal case is pending in a court of law for violence against any member of teaching/non-teaching staff inside or outside the campus.
- (iii) A candidate who has been convicted by a court of law for an offence involving moral turpitude or for similar offences.
- (iv) A candidate guilty of misconduct or misbehaviour or use of abusive language towards any member of teaching/non-teaching staff at the time of admission.

B. DEFINITION OF RESIDENT

The expression Residents of Rajasthan shall be interpreted as under:

Must have been in Rajasthan and his/her father must have resided in Rajasthan for a period of ten years. A certificate from the District Magistrate concerned will have to be produced as a proof thereof.

OR

Is a son/daughter of an employee of the Government of Rajasthan, Government Undertakings, Corporations or Municipal Boards, Panchayat Samities or Universities of Rajasthan or Board of Secondary Education, Rajasthan or affiliated Colleges of J.N.V. University.

OR

Is a son/daughter of a permanent employee of the Central Government/ Reserve Bank of India and other State Banks and government of India Undertakings (Corporations and Railways) provided his/her parents or guardians have been posted in the State of Rajasthan.

OR

All candidates who pass their Senior Higher Secondary Examination from the Board of Secondary Education, Rajasthan, Ajmer.

OR

Sons and daughters of parents who are doing business or are employees and have settled down in Rajasthan. Such candidates will have to produce a certificate of residence from Collectors/S.D.O./Tehsildar.

C. CONCESSIONS AND RESERVATIONS

- (i) **For SC, ST, OBC, MBC & EWS candidates:** For all types of admissions, except where special provision in this respect has been made, 16% , 12%, 21% 5% and 10% seats shall be reserved for the candidates belonging to SC, ST, OBC, MBC and EWS communities, respectively.

KM category: 5% of the total intake capacity over and above the sanctioned strength in each Department will be reserved for Kashmiri Migrants.

S.C./S.T./O.B.C. communities should be given relaxation of 5 percent marks from the minimum required percentage for admission in all faculties. If seats reserved for them still remain unfilled, further relaxation be given and all reserved seats filled by candidates belonging to those categories in various faculties of University except where special provision in this respect has been made.

- (ii) **For Persons with Disabilities** (For all types of admission) :

5 percent seats shall be horizontally reserved for Persons with Disabilities (PWD) candidates, and 5% seat over and above sanctioned strength for Kashmiri migrants with a minimum of one seat where the percentage works out to be less than one. Disabled candidates will get 5 percent relaxation in all types of eligibilities for admission on production of medical certificates countersigned by C.M. & H.O. or an equivalent authority. Also 5% seats shall be reserved each for the Kashmiri Migrants. This concession allowed under C (i) and C (ii), to make candidate eligible for fulfilling the quota and not enhancing position in merit.

Note : No seats reserved for SC, ST, OBC, MBC, EWS and candidates be filled by such candidates as are eligible in order of merit to be determined from amongst them only. If a SC, ST, OBC, MBC, EWS and PWD or Physically Handicapped candidate is admitted to the general quota on his own merit, his admission shall not be counted towards reserved quota.

- (iii) **Reservation for Teachers:**

One seat in each of the subjects of M.Sc. Classes is reserved for a teacher to be nominated by the Director of Primary and Secondary Education. He will be admitted only if he fulfils the minimum eligibility conditions (i.e. if he has secured 48 percent marks at the B.Sc. examination) otherwise the seat shall be treated as a general seat and filled on the last day of admission only.

OTHER RULES

1. No fee shall be charged from orphan students in various courses run by our University at par with blind students. Orphan means a candidate who is minor and lost both his/her parents in childhood or lost both his/her parents in covid period.
2. A weightage of 5% shall be given on the marks obtained in the qualifying examination to those students who studied in rural area of jurisdiction of the University seeking admission in Undergraduate Courses. Above concession will be given to those students subject to production of a certificate issued by the Sarpanch stating that the student passed XII class from rural area school.
3. A weightage of 10% on the marks obtained in the last qualifying examination be given to the wards of the all university employees (Teaching/Non-teaching).
4. Change of optional/special papers at the postgraduate level will be permitted by the Head of Department within 15 days from the starting of the Academic session for old scheme programs and for programs running under NEP-2020 Local Credit Monitoring Committee will take care of such cases.
5. Change of optional/special papers at the undergraduate level will be permitted by the concerned Head of the Institution (Dean/Director) within 15 days from the starting of the Academic session for old scheme programs and for programs running under NEP-2020 Local Credit Monitoring Committee will take care of such cases.
6. It will be mandatory for all students under NEP or OLD SCHEME to register for an account to store his/her credits earned in the Academic Bank of Credit for which he or she will have his own id and password.

SCHEME OF EXAMINATION AND GUIDELINES FOR POSTGRADUATE PROGRAMS OF FACULTY OF ARTS/ SCIENCE/COMMERCE BASED ON SEMESTER and CHOICE BASED CREDIT SYSTEM OF NEP-2020 FROM ACADEMIC YEAR 2023-24

Definitions of Key Words:

1. **Academic Year:** Two consecutive (one odd + one even) semesters constitute one academic year.
2. **Semester:** Each semester will consist of 15-18 weeks of academic work equivalent to 90 actual teaching days. The PAVAS (पावस, SUMMER) or odd semester may be scheduled from July to December. End of Semester Examination (EoSE) of the Pavas Semester may commence from Dec. 1 and the Semester break from Dec. 16 to Dec. 31; and BASANT (बसंत, SPRING) or even semester from January to May. The Basant Semester will be followed by the Annual Summer Break from Sixteenth May to Thirtieth June.
The Vice-Chancellor may amend the timeline in a particular session keeping in view prevailing circumstances.
3. **Program:** An educational program leading to award of the Undergraduate-/Postgraduate Degrees/Diplomas/Certificates in the Core subjects in which he/she is admitted.
4. **Course:** Usually referred to, as 'papers' is a component of a program. All courses need not carry the same weightage. The courses should define learning objectives and learning outcomes.
5. **Credit Based Semester System (CBSS):** Under the CBSS, the requirement for awarding a degree is prescribed in terms of number of credits to be completed by the students.
6. **Credit Point:** It is the product of grade point and number of credits for a course.
7. **Credit:** A unit by which the course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one period of teaching (lecture or tutorial) or two periods of practical work/field work per week.
8. **Choice Based Credit System (CBCS):** The CBCS provides choice to students to select from the prescribed elective, ability-, and skill enhancement courses. Students can also avail facility of online courses available in other Universities/Institutions and websites approved by Jai Narain Vyas University.

A student needs to select 10 credits Discipline Centric Core (DCC) Courses in which he/she intends to do core course out of the core courses offered by the Faculty/College/Department/Centers. These Core Courses will continue to be part of the program during first, second, third and fourth semester.

A student needs to select 10 credits Discipline Specific Elective (DSE) Courses offered by the Faculty/College/Department/Centers during first, second, third and fourth semester.

9. A student has to earn total 80 credits in his/her two year (four semesters) PG degree program, 20 credits from each semester. These 80 credits are to be earned out of DCC and DSE courses. We can also have DSE Generic Courses if offered by the Department/College. In addition to normal courses of DSE, we have, DSE Specific Type courses like Dissertation/Project Work/ Field Study, Internship/ On-Job Experience, Community Engagement Course, Seminar, and Research Credit Courses.
10. Out of 80 credits 40 credits compulsorily be earned from DCC courses of an Academic Program to attain the Academic Qualification. Not more than 60 % of Credit requirement for a program shall be courses which are Discipline Centric Core Compulsory courses for the program.
11. In case of one semester Certificate Program separately designed and run by any College/ Department/ Centers then it will be entitled with NHEQF Level, credits and title of program, for example 'Twenty Credit (NHEQF Level 6) Certificate of Gems & Jewelry'
12. **Semester Grade Point Average (SGPA):** It is a measure of performance of work done in a semester. It is ratio of total credit points secured by a student in various courses registered in a semester and the total course credits taken during that semester. It shall be expressed up to two decimal places.
13. **Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative performance of a student over all the semesters of a program. The CGPA is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all the semesters. It is expressed up to two decimal places.
14. **Grade Point:** It is a numerical weightage allotted to each letter grade on a 10-point scale.
15. **Letter Grade:** It is an index of the performance of students in a said course. Grades are denoted by letters O, A+, A, B+, B, C, P, and F.
16. **Transcript or Grade Card or Certificate:** Based on the grades earned, a statement of grades obtained shall be issued to all the registered students after every semester. This statement will display the course details (code, title, number of credits, grade secured) along with SGPA of that semester and CGPA earned till that semester.
17. **Transcript or Grade Card or Diploma/Degrees:** The University will issue a complete transcript of credits, grades obtained, SGPA and CGPA on declaration of each semester result and a Cumulative Transcript on the accumulation of minimum credits required for the award of Diploma/Degree when EXIT is sought by the student.
18. **Examination and Assessment:** Students' examination and assessment Procedure of All courses (Core/Elective/ Skill/Ability) will involve the following two

components:

- (i) Continuous Assessment (CA): It will have 30% weightage of the Maximum Marks of that particular course.
- (ii) End of Semester Examination (EoSE): It will have 70% weightage of the Maximum Marks of that particular course (or marks earned out of M.M.70).

Continuous Assessment: The schedule and pattern of continuous assessment/evaluation should be decided by the concerned faculty/college/ department/ center where the course is being delivered and the same shall be publicized in advance to all students and faculties through the institutional regulations and the students' information brochure. The components of Continuous Assessment are to have a time frame for completion by students with concurrent and continuous evaluation by the faculty members. Following the principle of "those who teach should evaluate", the continuous assessment/evaluation has to be conducted by the concerned teacher and the evaluation outcome should be expressed by grades.

In Continuous Assessment, due emphasis shall be given to assessing cognitive skills such as logical thinking, application of knowledge and skills, and analysis and synthesis of concepts and rules. Thus, innovative evaluation strategies other than mid-term tests should also be devised as a part of CA. Innovative evaluation strategies are to be used by the concerned faculty/department/teachers during the semester.

Continuous Assessments (CA) are based on open evaluation system without any bias to any student.

For the sake of convenience, the CA of 30 marks may be expanded to 100 marks which may have the following components:

- a. Quizzes of 30 marks: It may consist multiples choice answers, fill in the blanks / true-false questions/ short answer/ seminar/assignment as designed by Faculty/ College/ Department/ Centers.
- b. Mid-term test of 70 marks
Mid-term exam to be conducted on completion of all units.

19. Scheme of Examination for Mid-term test and End of Semester Examination (EoSE) for DCC and DSE Courses:

The question paper for the DCC and DSE courses will be of 70 marks and it will be divided into two parts i.e., Section – A and Section – B.

Section – A: Will consist of 10 compulsory questions. There will be two questions from each unit and answers to each question shall be limited up to 30 words. Each question will carry 2 marks. Total 20 marks.

Section – B: Will consist of 10 questions. Two questions from each unit will be set and students will answer one question from each Unit. The answer to each question shall be limited to 500 words. Each question carries 10 marks. Total 50 marks.

20. Scheme of Examination for Mid-term test and End of Semester Examination (EoSE) AEC and SEC courses:

The question paper for the AEC and SEC courses will be of 70 marks and it will be divided into two parts i.e., Section – A and Section – B.

Section – A: It will consist of 10 compulsory questions. There will be set minimum three questions from each unit and answers to each question shall be limited up to 30 words. Each question will carry 2 marks. Total 20 marks.

Section – B: It will consist of 10 questions. Minimum three questions will be set from each unit and students will answer five questions in total but not more than two questions from one Unit. The answer to each question shall be limited to 500 words. Each question carries 10 marks. Total 50 marks.

21. Each component marks of CA will be added without rounding and the total thus obtained out of hundred will be added and 30% of those marks will be awarded to a student.

For example

Marks obtained in quizzes/Seminar/ Assignment out of 30 = 19.50

Marks obtained in Mid-term test out of 70 = 50.50

Total $19.50 + 50.50 = 70.00$

Conversion into 30% = $\frac{70 \times 30}{100} = 21.00$

Marks to be award out of 30 = 21.00

Marks to be rounded up to the higher number, if in decimals eg. 19.34 = 20

22. Classroom Attendance – Each student will have to attend a minimum of 75% Lectures / Tutorials / Practical. A student having less than 75% attendance will not be allowed to appear in the End of Semester Examination (EoSE).

23. End of Semester Examination (EoSE) Marks: EoSE will carry Maximum Marks 70 irrespective of credits of the course. The marks obtained and the grade shall be specified in the Grade Sheet. The scheme of Examination for EoSE for each course will be specified in the course syllabus.

24. In laboratory courses (having only practical (P) component), the CA will be based on student's attendance; Practical records, hands on Practical in physical science stream and biological and earth science stream.

25. Qualifying for EoSE examination: A student acquiring minimum of 40% in total of the CA of individual course is eligible to appear in the End of Semester Examination (EoSE).

26. National Higher Education Qualification Framework (NHEQF) Levels

Introduction: Qualifications are formal 'awards' such as a certificate, diploma, or a degree. Qualifications are awarded by a competent authority such as a college or university in recognition of the attainment by students of the expected learning outcomes on the successful completion of a particular programme of study. They are awarded after an assessment and evaluation of learning levels conducted by a competent body that determines the achievement by students of the expected learning outcomes to given standards.

A National Qualifications Framework (NQF) is an instrument for the classification of qualifications according to a set of criteria for specified levels of learning achieved, which would integrate and coordinate the qualifications from each education and training sector into a single comprehensive qualification framework. It is a way of structuring existing and new qualifications, which are defined by learning outcomes reflecting the graduate profile/attributes, programme learning outcomes, and course learning outcomes: i.e., statements of what the learner is expected to know, understand and/or be able to do and demonstrate on the successful completion of an approved programme of study/learning. The NQF helps: (a) improve the transparency of individual qualifications through the defined learning outcomes; (b) enhance the understanding of the education and training systems; (c) promote credit accumulation and transfer within and between programmes of study; (d) provide an instrument of accountability of the education and training systems; (e) make education and training systems more demand-focused and user friendly; (f) reduce the 'mismatch' between education and the labour market; and (g) facilitate the recognition of prior learning.

Qualifications that signify completion of the Master's degree, as per the learning outcomes that are aligned to the Dublin descriptors, are awarded to students who: i) have demonstrated knowledge and understanding that is founded upon and extends and/or enhances that typically associated with the first cycle, and that provides a basis or opportunity for originality in developing and/or applying ideas, often within a research context; ii) can apply their knowledge and understanding, and problem solving abilities in new or unfamiliar environments within broader (or multidisciplinary) contexts related to their field of study; iii) have the ability to integrate knowledge and handle complexity, and formulate judgments with incomplete or limited information, but that include reflecting on social and ethical responsibilities linked to the application of their knowledge and judgments; iv) can communicate their conclusions, and the knowledge and rationale underpinning these, to specialist and non-specialist audiences clearly and unambiguously; v) have the learning skills to allow them to continue to study in a manner that may be largely self-directed or autonomous.

The NHEQF levels represent a series of sequential stages expressed in terms of a range of learning outcomes against which typical qualifications are positioned/located. NHEQF level 4.5 represents learning outcomes appropriate to the first year (first two semesters) of the undergraduate programme of study, while Level 8 represents learning outcomes appropriate to the doctoral-level programme of study (see Table given below).

Conversion of CGPA to Percentage: To convert CGPA to percentage the CGPA be multiplied by Ten. Thus, CGPA of 7.23 will get converted to 72.3%. Because of the grading system the percentage calculated on the basis of conversion may be different then percentage calculated by the consideration of actual marks obtained in courses. The percentage based on CGPA conversion shall be mentioned in the final cumulative grade sheet and shall be treated as final and valid value of percentage for all purpose.

34. Improvement/supplementary Option: There will be no supplementary/ due paper/ special examination for any course. The candidates can improve performance in the subsequent EoSE and performance in that appearance will overwrite earlier performance. Student will have to prepare on his own for improvement. Improvement in CA will not be permitted.

35. Any grievance of a student received in the Department shall be placed before the Grievance Redressal Committee with adjudicated comments.

36. Grievances and Redressal Mechanism

a) The students will have the right to make an appeal against any component of evaluation. Such appeal has to be made to the Chairperson/Dean of the Faculty, Director/Principal of the College or the Head of Department concerned as the case

may be clearly stating in writing the reason(s) for the complaint / appeal.

b) The appeal will be assessed by the Chairman and he/she shall place before the Grievance Redressal Committee (GRC), Chaired by the Dean of the concerned Faculty, Director/Principal of the College comprising all HODs of the Faculty/College and, if need, Course Teacher(s) be called for suitable explanation; GRC shall meet at least once in a semester and prior to CA finalization.

c) The Committee will consider the case and may give a personal hearing to the appellant before deciding the case. The decision of the Committee will be final.

37. The distribute of the Periods between L-Theory/T-Tutorial/P-Practical and S-Special type courses as per the Course content and the need of the course. However, for the selection example is given below:

4:0:0:0 (four lectures only (no tutorial, no practical, no special per week).

The Duration of the Period shall be one hours for theory and two hours for practical.

In each practical group the number of students that can be accommodated in the general/existing pattern is 15 students in each group of PG programs. The workload is to be computed accordingly.

38. Cumulative attendance of all the students shall be displayed on the Department's Notice Board every month with a copy to the Dean, Faculty of Science.

Scheme of Examination and Guidelines for Undergraduate Programs of Faculty of Arts/Science/Commerce based on Semester and choice based credit System of NEP-2020 from Academic Year 2023-24

Definitions of Key Words:

1. **Academic Year:** Two consecutive (one odd + one even) semesters constitute one academic year.
2. **Semester:** Each semester will consist of 15-18 weeks of academic work equivalent to 90 actual teaching days. The PAVAS (पावस, SUMMER) or odd semester may be scheduled from July to December. End of Semester Examination (EoSE) of the Pavas Semester may commence from Dec. 1 and the Semester break from Dec. 16 to Dec. 31; and BASANT (बसंत, SPRING) or even semester from January to May. The Basant Semester will be followed by the Annual Summer Break from Sixteenth May to Thirtieth June.
The Vice-Chancellor may amend the timeline in a particular session keeping in view prevailing circumstances.
3. **Program:** An educational program leading to award of the Undergraduate-/Postgraduate Degrees/Diplomas/Certificates in the Core subjects in which he/she is admitted.
4. **Course:** Usually referred to, as 'papers' is a component of a program. All courses need not carry the same weightage. The courses should define learning objectives and learning outcomes.
5. **Credit Based Semester System (CBSS):** Under the CBSS, the requirement forwarding a degree is prescribed in terms of number of credits to be completed by the students.
6. **Credit Point:** It is the product of grade point and number of credits for a course.
7. **Credit:** A unit by which the course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one period of teaching (lecture or tutorial) or two periods of practical work/ field work per week.
8. **Choice Based Credit System (CBCS):** The CBCS provides choice to students to select from the prescribed elective, ability, and skill enhancement courses. Students can also avail facility of online courses available in other Universities/Institutions and websites approved by Jai Narain Vyas University.

A student needs to select three Discipline Centric Core (DCC) Courses in which he/she intends to opt core courses out of the core courses offered by the Faculty/College/ Department/Centres. These Core Courses will continue to be part of the program during first, second, third and fourth semester to get 72 credits of DCC. The core courses will be allotted to students on the basis of merit and availability of seats in the concerned Faculty/College/ Department/Centres.

A student needs to select three Discipline Specific Elective (DSE) Courses offered by the Faculty/College/ Department/Centres during fifth and sixth semester to get 36 credits of DSE.

Each student has to complete two Ability Enhancement Compulsory (AEC) Courses of 04 credits (two credits in the semester I and two credits in the semester II).

A student has to take one Skill Enhancement Course (SEC) of two credits in every semester from III to VI semester (total four courses and 08 credits). These courses can be opted either from the pool of ability-/ skill enhancement courses provided by the JNV University or from the courses provided by other universities/institutions and approved by JNV University.

9. A student has to earn total 120 credits in his/her three year (six semesters) UG degree program, 20 credits from each semester. These 120 credits to be earned from different type of courses viz. 72 credits from DCC, 36 credits from DSE, 04 credits from AEC and 08 credits from SEC courses.
10. In case of one semester Certificate Program separately designed and run by any College/ Department/ Centers then it will be entitled with NHEQF Level, credits and title of program, for example 'Twenty Credit (NHEQF Level 4.5) Certificate of Gems & Jewelry'. Similarly, two semester Certificate/Diploma Program (other than part of B.A./B.Sc./B.Com. programs) will be entitled with NHEQF Level, credits and title of program, for example 'Forty Credit (NHEQF Level 4.5) Diploma of Gems & Jewelry'.
11. **Semester Grade Point Average (SGPA):** It is a measure of performance of work done in a semester. It is ratio of total credit points secured by a student in various courses registered in a semester and the total course credits taken during that semester. It shall be expressed up to two decimal places.
12. **Cumulative Grade Point Average (CGPA):** It is a measure of overall cumulative performance of a student over all the semesters of a program. The CGPA is the ratio of total credit points secured by a student in various courses in all semesters and the sum of the total credits of all courses in all the semesters. It is expressed up to two decimal places.
13. **Grade Point:** It is a numerical weightage allotted to each letter grade on a 10-point scale.
14. **Letter Grade:** It is an index of the performance of students in a said course. Grades are denoted by letters O, A+, A, B+, B, C, P, and F.
15. **Transcript or Grade Card or Certificate:** Based on the grades earned, a statement of grades obtained shall be issued to all the registered students after every semester. This statement will display the course details (code, title, number of credits, grade secured) along with SGPA of that semester and CGPA earned till that semester.
16. **Transcript or Grade Card or Diploma/Degrees:** The University will issue a complete transcript of credits, grades obtained, SGPA and CGPA on declaration of each semester result and a Cumulative Transcript on the accumulation of minimum credits required for the award of Diploma/Degree when EXIT is sought by the

student.

17. Examination and Assessment: Students' examination and assessment Procedure of All courses (Core/ Elective/ Skill/ Ability) will involve the following two components:
 - (i) Continuous Assessment (CA): It will have 30% weightage of the Maximum Marks of that particular course.
 - (ii) End of Semester Examination (EoSE): It will have 70% weightage of the Maximum Marks of that particular course (or marks earned out of M.M.70).

Continuous Assessment: The schedule and pattern of continuous assessment/evaluation should be decided by the concerned faculty/college/ department/ center where the course is being delivered and the same shall be publicized in advance to all students and faculties through the institutional regulations and the students' information brochure. The components of Continuous Assessment are to have a time frame for completion by students with concurrent and continuous evaluation by the faculty members. Following the principle of "those who teach should evaluate", the continuous assessment/evaluation has to be conducted by the concerned teacher and the evaluation outcome should be expressed by grades.

In Continuous Assessment, due emphasis shall be given to assessing cognitive skills such as logical thinking, application of knowledge and skills, and analysis and synthesis of concepts and rules. Thus, innovative evaluation strategies other than mid-term tests should also be devised as a part of CA. Innovative evaluation strategies are to be used by the concerned faculty/ department/ teachers during the semester.

Continuous Assessments (CA) are based on open evaluation system without any bias to any student.

For the sake of convenience, the CA of 30 marks may be expanded to 100 marks which may have the following components:

- a. Quizzes of 30 marks: It may consist of multiples choice questions, fill in the blanks- /true-false- / short answer-questions / seminar/assignments designed by Faculty/ College/ Department/ Centers.

In case of five-unit courses, marks may be distributed as given below:

Seminar to be held on completion of two units - 05 marks

Quiz to be held on completion of three units - 20 marks

Assignment to be taken on completion of four units - 05 marks

- b. Mid-term test of 70 marks

Mid-term exam to be conducted on completion of all units.

18. **Scheme of Examination for Mid-term test and End of Semester Examination (EoSE) for DCC and DSE Courses:**

The question paper for the DCC and DSE courses will be of 70 marks and it will be divided into two parts i.e., Section – A and Section – B.

Section – A: Will consist of 10 compulsory questions. There will be two questions from each unit and answers to each question shall be limited up to 30 words. Each question will carry 2 marks. Total 20 marks.

Section – B: Will consist of 10 questions. Two questions from each unit will be set and students will answer one question from each Unit. The answer to each question shall be limited to 500 words. Each question carries 10 marks. Total 50 marks.

19. Scheme of Examination for Mid-term test and End of Semester Examination (EoSE) AEC and SEC courses:

The question paper for the AEC and SEC courses will be of 70 marks and it will be divided into two parts i.e., Section – A and Section – B.

Section – A: It will consist of 10 compulsory questions. There will be set minimum three questions from each unit and answers to each question shall be limited up to 30 words. Each question will carry 2 marks. Total 20 marks.

Section – B: It will consist of 10 questions. Minimum three questions will be set from each unit and students will answer five questions in total but not more than two questions from one Unit. The answer to each question shall be limited to 500 words. Each question carries 10 marks. Total 50 marks.

20. Each component marks of CA will be added without rounding and the total thus obtained out of hundred will be added and 30% of those marks will be awarded to a student.

For example

Marks obtained in quizzes/Seminar/ Assignment out of 30 = 19.50

Marks obtained in Mid-term test out of 70 = 50.50

Total $19.50 + 50.50 = 70.00$

Conversion into 30% $= \frac{70 \times 30}{100} = 21.00$

Marks to be award out of 30 = 21.00

Marks to be rounded up to the higher number, if in decimals eg. 19.34 = 20

21. **Classroom Attendance** – Each student will have to attend a minimum of 75% Lectures / Tutorials / Practical. A student having less than 75% attendance will not be allowed to appear in the End of Semester Examination (EoSE).

22. End of Semester Examination (EoSE) Marks: EoSE will carry Maximum Marks 70 irrespective of credits of the course. The marks obtained and the grade shall be specified in the Grade Sheet. The scheme of Examination for EoSE for each course will be specified in the course syllabus.
23. In laboratory courses (having only practical (P) component), the CA will be based on student's attendance; Practical records and hands on Practical in concerned courses.
24. **Qualifying for EoSE examination:** A student acquiring minimum of 40% in total of the CA of individual course is eligible to appear in the End of Semester Examination (EoSE).
25. **National Higher Education Qualification Framework (NHEQF) Levels**

Introduction: Qualifications are formal 'awards' such as a certificate, diploma, or a degree. Qualifications are awarded by a competent authority such as a college or university in recognition of the attainment by students of the expected learning outcomes on the successful completion of a particular programme of study. They are awarded after an assessment and evaluation of learning levels conducted by a competent body that determines the achievement by students of the expected learning outcomes to given standards.

A National Qualifications Framework (NQF) is an instrument for the classification of qualifications according to a set of criteria for specified levels of learning achieved, which would integrate and coordinate the qualifications from each education and training sector into a single comprehensive qualification framework. It is a way of structuring existing and new qualifications, which are defined by learning outcomes reflecting the graduate profile/attributes, programme learning outcomes, and course learning outcomes: i.e., statements of what the learner is expected to know, understand and/or be able to do and demonstrate on the successful completion of an approved programme of study/learning. The NQF helps: (a) improve the transparency of individual qualifications through the defined learning outcomes; (b) enhance the understanding of the education and training systems; (c) promote credit accumulation and transfer within and between programmes of study; (d) provide an instrument of accountability of the education and training systems; (e) make education and training systems more demand-focused and user friendly; (f) reduce the 'mismatch' between education and the labour market; and (g) facilitate the recognition of prior learning.

Qualifications that signify completion of the Bachelor's degree, as per the learning outcomes that are aligned to the Dublin descriptors, are awarded to students who: i) have demonstrated knowledge and understanding in a field of study that builds upon their general secondary education, and is typically at a level that, whilst supported by advanced textbooks, includes some aspects that will be informed by knowledge of the forefront of their field of study; ii) can apply their knowledge and understanding in a manner that indicates a professional approach to their work or vocation, and have competences typically demonstrated through devising and sustaining arguments and solving problems within their field of study; iii) have the ability to gather and interpret relevant data (usually within their field of study) to inform judgments that include reflection on relevant social, scientific or ethical issues; iv) can

communicate information, ideas, problems and solutions to both specialist and non-specialist audiences; v) have developed those learning skills that are necessary for them to continue to undertake further study with a high degree of autonomy.

The NHEQF levels represent a series of sequential stages expressed in terms of a range of learning outcomes against which typical qualifications are positioned/located. NHEQF level 4.5 represents learning outcomes appropriate to the first year (first two semesters) of the undergraduate programme of study, while Level 8 represents learning outcomes appropriate to the doctoral-level programme of study (see Table given below).
