

As per decision taken by the Admission Board held on 10.06.2023 vide Res.No.08/2023, it is hereby notified that if a candidate opt to withdraw from the program of study in which he/she is enrolled, the University shall follow the following four-tier system for the refund of fees remitted by the student from the Academic Session 2023-24, as per provisions laid down in para 4.2 (sub para 4.2.3) of UGC Notification D.O.No.1-3/2007/(CPP-II) dated 6.12.2016:


