On the recommendation of the workload committee of the Department of Physical Education the Vice Chancellor has been pleased to sanction for engaging the following Faculties for Self Sufficiency Course (against MPEd & DYEd) on remuneration @ Rs. 375/- for 45 minutes, Rs. 458/- for 55 minutes & Rs. 500/- for 01 hour per period with condition that the amount of remuneration does not exceed to Rs. 25000/- per month against the extra teaching workload with effect from the date mentioned against each for the session 2022 - 2023:

In pursuant to the decision of the Syndicate vide Resolution No. 40/2022 dated 17th September, 2022, the Guest Faculty remuneration shall be paid parellel to "Vidya Sambal Yojna" to the level of Assistant Professor at Rs. 600/- for 45 minutes, Rs. 733/- for 55 minutes and Rs. 800/- for 1 hour and the same does not exceed Rs.45000/-. Similarly to the level of Associate Professor at Rs. 750/- for 45 minutes, Rs.916/- for 55 minutes and Rs. 1000/- for 1 hour and the same does not exceed Rs.52000/- and to the level of Professor at Rs. 900/- for 45 minutes, Rs.1100/- for 55 minutes and Rs. 1200/- for 1 hour and the same shall not exceed Rs.60000/-. The said remuneration shall be made effective from 18th September, 2022.
