ORDER

The Vice-Chancellor has been pleased to grant permission to start the Master of Physical Education Course of two year duration in the Faculty of Arts, Education & Social Sciences from the Academic Session 2002-2003 with the following terms & conditions :

- i) The Course shall run under self financing scheme. The University shall not provide any financial assistance.
- ii) Shri O.P. Sharma shall be the Coordinator of M.P.E. Course. Shri R.S. Karnot shall be the Chief Coordinator (who shall co-ordinate the programmes of M.P.E. and B.A. Part-I optional paper in Physical Education). Dr. A.S. Sissodia shall be the Coordinator of B.A. Part - I optional paper on Physical Education.

All bills/proposals for expenditure/or any other related matter to be submitted by the Coordinator to the University shall be routed through the Chief Coordinator.
- iii) For M.P.E. programme a joint account shall be opened in the Bank of Haroda, i.e. the Coordinator of M.P.E. and the Financial Advisor. The account shall be operated under the joint signature.
- iv) The maximum number of seats in M.P.E. shall be 30 (thirty). No payment seat is allowed.
- v) The reservation policy of the Government shall be strictly followed while doing admissions.
- vi) The tuition fees for M.P.E. course shall be Rs. 15000/- per year. It shall be collected at the time of admission. Apart from tuition fees, the other fees as prescribed by the University or the Board of Sports (proposed Department of Physical Education) shall be charged.
- vii) The syllabus already approved by the Academic Council be followed.

- viii) The work-load for regular teachers shall be :
- a) In the grade of Readers/Professors : 18 periods per week, each period of 45 minutes duration.
 - b) In the grade of Lecturers : 21 periods per week, each period of 45 minutes duration.
- ix) In case the work load exceeds the above norms, then for those excess periods allowance as per University rules will be admissible (subject to the recommendations by the Work - Load Committee).
- x) The external (not in regular service) teachers, or Guest Faculty shall be paid an allowance of Rs. 75/- per period.
- xi) A certain percentage of amount shall be deposited in the Main Account every year as per the rules of the University.
- xii) The rules of admission, prospectus, admission forms and related matters be finalized early and be got printed.
